# 5. THE REPORT

## 5.1 Notice of Motion

In his notice of motion Councillor Etheridge states: -

We the undersigned Elected Members in response to public opposition and the petition of over 5000 people against the proposal to mothball the Blackwood Miners Institute, call on Council to defer any decision on the future of Blackwood Miners Institute (BMI) to the end of the 2024/2025 financial year (31<sup>st</sup> March 2025) and that it should be discussed when the formal Draft Budget Proposals 2025/2026 are presented for consideration by full Council in February 2025. Where, in the interest of openness and transparency all elected Members can debate the proposals in the proper context.

5.2 In support of his notice of motion Councillors Etheridge states that although this may be an executive function, the future of such an historic and valued community asset should be a matter for full Council to debate. Also, that consideration solely by Cabinet at this time would be premature as all alternative funding streams to save the BMI have not been fully explored.

This additional time will also allow detailed engagement with all stakeholders and community groups and that every opportunity to secure alternative management/financial support for this historic and treasured community asset is looked at.

In conclusion the motion proposes that Cabinet in its position as Trustees should be safeguarding the BMI for generations to come rather than moving ahead with proposals to mothball/close the venue without first having explored every possible way to save it.
