#### 1. PURPOSE OF REPORT

#### 5. THE REPORT

5.1 Notice of Motion

In his notice of motion Councillor Etheridge calls on Caerphilly Council to fund any improvements necessary regarding Cefn Fforest Leisure Centre through internal grants, Senedd Funding and Reserves and not impose any rationalisation on this facility which serves many communities and schools within this area.

The facility contributes to the wellbeing of the population within the respective wards of Argoed, Cefn Forest, Pengam, Blackwood, Pontllanfraith and beyond.

- 5.2 Officers provide the following information in relation to the notice of motion. A 7-week public consultation is being undertaken in relation to a proposal to close the Cefn Fforest Leisure Centre and also Bedwas and New Tredegar leisure centres. The outcome of the consultation will be reported to a future meeting of this Scrutiny Committee.
- 5.3 The most recent building condition survey for Cefn Fforest Leisure Centre undertaken in October 2024 identified repair and basic maintenance works totalling £334,453. There are no sources of external funding for these works. The net annual revenue budget for the leisure centre in 2024/25 is £441,602 and even if the maintenance works identified were undertaken this annual cost to the Council of operating the facility would remain.
- 5.4 Members will be aware that the council faces an anticipated savings requirement of £47.456m for the three-year period 2025/26 to 2027/28.

## 6. ASSUMPTIONS

6.1 As a notice of motion is a procedural matter and must be dealt with in accordance with Council's Constitution, no assumptions have been made.

## 7. SUMMARY OF INTEGRATED IMPACT ASSESSMENT
