1 Introduction and context

- 1.1 This paper gives an overview of the recent peer review of Camden's Adult Social Care services organised by ADASS (Association of Directors of Adult Social Care). A team of peer reviewers visited Camden in May 2023 to undertake the review, which consisted of a case file audit, a review of our current self-assessment and related evidence, and nearly 40 interview sessions with staff, partners and people who draw on care.
- 1.2 Alongside positive feedback the review team offered very useful feedback about the things we need to focus on to ensure that every Camden resident can draw on exceptional care and support. A full report supplied by the reviewers detailed their core findings, as well as their additional observations and feedback.
- 1.3 Camden Adult Social Care are now working out an action plan detailing all of the tangible actions that will be undertaken in light of the learning that has been garnered from the experience of the review. The actions in question derive primarily from the peer review team's feedback, but will also incorporate learning from Camden Adult Social Care's reflections and those of Camden's leadership.
