- 1.1. The Covid19 pandemic brought unprecedented challenges to the NHS. Primary care was no exception. From maintaining services through the early phases of the pandemic, through the Covid19 vaccination programme, and to post-Covid19 recovery, general practice nationally, and in Camden, has played a leading role in the NHS' response.
- 1.2. While Covid19 placed significant operational and workforce pressures on primary care teams, it also fostered innovation, transformation, collaboration and improvement in ways which would have been hard to envisage previously.
- 1.3. The ICB previously brought an annual update on the state of Camden primary care to the committee.
