

Please find below confirmation of the measures agreed, without prejudice, relating to the premises licence application for 185 Drury Lane, LONDON, WC2B 5PR.

#### **Opening hours:**

Monday - Sunday: 10:00 - 22:00 (as applied for)

#### Sale of alcohol:

Monday - Sunday: 12:00 - 21:30hrs

#### **Conditions agreed with Metropolitan Police:**

- 1. The sale of alcohol shall only be legitimate whilst the permitted use of the premises for planning purposes remains that of a museum / gallery.
- 2. Alcohol sales will be ancillary to the main purpose of the venue which is a museum / gallery.
- 3. The number of persons permitted in the premises at any one time, excluding staff shall not exceed 60 persons at any one time.
- 4. The consumption of alcohol on the premises shall cease at 2200 hours.
- 5. Patrons permitted to temporarily leave and then re-enter the premises, e.g. to smoke, shall not be permitted to take drinks or glass containers with them.
- 6. Police must be called to all incidents of crime and/or serious disorder.
- 7. The CCTV system shall be maintained in good working order and at all times the premises is open to the public, be fully operational covering all internal and external areas of the premises to which the public have access. The CCTV camera views are not to be obstructed.
- 8. CCTV recordings must be concurrent with accurate time.
- At least one CCTV camera is to be placed no more than seven feet above floor level; near to the exit in order to capture clear facial images of all persons leaving the premises.
- 10. The medium on which CCTV images are recorded shall be of evidential quality; stored securely; shall be retained for a period of 31 days; and be available for inspection by the Police or Local Authority upon request with 48 hours.
- 11. At all times when the premises are open for the purposes of licensable activities, a suitably trained member of staff shall be present to assist the Police or an authorised officer of the Licensing Authority in obtaining the CCTV footage.
- 12. The facility to transfer the images to a compatible, removable format, shall be held on the premises.
- 13. At least one Staff working at the premises at any one time shall be trained in the use of CCTV and a log will be kept to verify this.
- 14. Signs must be displayed in the customer areas to advise that CCTV is in operation.
- 15. If the CCTV is inoperative or not installed and working to the satisfaction of the Police, then within 48 hours the Police shall be notified and an estimate given of the repair timescale. The premises shall comply with all reasonable requests from the Police.
- 16. A Challenge 25 policy will be enforced, where any person reasonably looking under the age of 25 shall be asked to prove their age when attempting to purchase alcohol and signs to this effect will be displayed at the premises. The only acceptable forms of identity will be those with photographic

- identification documents recognised in the Home Office guidance; including passports, photo-card driving licence or proof of age card bearing the PASS hologram.
- 17. Staff training records shall be available for inspection by authorised officers of the licensing authority, officers of the trading standards service and officers of the Police.

# Additional conditions agreed, without prejudice, following mediation with Mr Kaner, CGCA:

- 18. Alcohol sales are restricted to people who have purchased tickets for exhibitions in the space.
- 19. The licence holder will use his best endeavours to discourage customers smoking on the public footway immediately outside the premises and to ensure that the pavement is not obstructed.

To mitigate any concerns relating to the intended use of the premises, our client is very happy to agree to the measures set out below:

The addition of the following conditions:

Alcohol sales are restricted to people who have purchased tickets for exhibitions in the space.'

Thanks for your email.

The CGCA does not believe that the proposed conditions related to ancillary sales go far enough.

- The sale of alcohol shall only be legitimate whilst the permitted use of the premises for planning purposes remains that of a museum / gallery.
  - 2. Alcohol sales will be ancillary to the main purpose of the venue which is a

museum / gallery.

I cannot find any evidence that museum/gallery is in fact the permitted planning use of the premises, and even it was our concern regards the actual use and not the permitted one. These conditions would not prevent you operating as a gallery during the day and a bar in the evening, as the bar use would be ancillary to the main use in planning terms.

This is why we would like a condition that alcohol sales are restricted to people who have purchased tickets for exhibitions in the space. This would seem to be consistent with your mode of operation. Please could you consider adding this?

We understand that the Licence Holder cannot prevent customers smoking outside. Please would you accept a "best endeavours condition"

The licence holder will use his best endeavours to discourage customers smoking on the public footway immediately outside the premises and to ensure that the pavement is not obstructed.

We are aware that some residents are concerned about the start time for the sale of alcohol (11am). Would you consider moving this to a later time (eg 00:00)?

#### **Overview**

The premises is described as an intimate new basement venue where art is brought to life and visitors experience 'immersive digital art' exhibits. Visitors to the gallery experience digital journey, where technology is combined with art to stimulate and cultivate the imagination. The sale of alcohol is ancillary to the experience and enjoyment of the gallery exhibit.

The premises is situated in an area within proximity to offices and residential properties.

#### **The Premises and Summary of Application**

The application is seeking authorisation to allow the following licensable activity:

Sale of Alcohol (For consumption on the premises)

The times being applied for the sale of alcohol are given as:

Monday to Sunday 11:00 – 21:30

#### **Framework Hours Policy**

The hours being applied for are within the framework hours. The framework hours are:

Monday to Thursday 10:00 am until 11:30 pm

- Friday and Saturday 10:00 am until midnight
- Sunday 11:00 am until 10:30 pm

#### **Cumulative Impact (Special Policy Areas)**

The premises are situated in the Seven Dials Cumulative Impact Policy area where there is a presumption to refuse all new and variation applications, as set out in Chapter Six of the Licensing Policy (Cumulative Impact Policies). While this presumption is rebuttable, this is only in exceptional circumstances and where the applicant has successfully demonstrated that the granting of their application would not contribute to the existing impact of licensed premises in that area.

The applicant has provided a number of conditions to promote the licensing objectives, which includes CCTV, staff training etc.

However, even with these conditions, granting the application will result in an overall increase in capacity at licensed premises in the area, which could add to additional people being on the street late at night and add to the cumulative impact in the area

## **Complaint History**

There is no history of complaints at this premises within the past two years.

#### **Conditions**

Chapter Seven of the Licensing Policy provides example conditions for different types of premises and licensable activity. The following premises policies in chapter seven are relevant for this application and have been used as a basis for recommending conditions that may be appropriate to promote the licensing objectives:

Theatres, cinemas, qualifying clubs and community premises

If Members are minded to grant the application, the following conditions are considered to be appropriate for the promotion of the licensing objectives, and are based on example conditions in the Licensing Policy:

- 1. Customers smoking on the public footway shall not be permitted to cause obstruction of the highway to passers by.
- 2. Notices shall be prominently displayed at any area used for smoking requesting patrons to respect the needs of local residents and use the area quietly.
- 3. The licence holder shall ensure that any queue to enter the premises which forms outside the premises is orderly and supervised by door staff so as to ensure that there is no public nuisance or obstruction to the public highway.

#### Conclusion

If Members are minded granting the application, then additional conditions can be attached as appropriate steps to promote the licensing objectives.

The onus is on the applicant to demonstrate to the panel the granting of their application would not contribute to the existing impact of licensed premises in the seven dials area. The application is to provide licensable activities within the Seven Dials Special Policy Area and therefore the presumption is that it should be refused in its entirety

This is an application for the sale of alcohol in an art gallery in the basement of 185 Drury Lane under a Social Housing block, Goldsmith Court. A map showing the location of the premises in relation to residents in the vicinity, and a picture showing the proximity to residents above are attached.

The statement accompanying the Application states that it is to allow gallery patrons to consume a drink as they go around the gallery, which includes an immersive digital experience. The hours requested are 11:00-21:30 on all days of the week.

On the face of it this application would seem fairly benign. However there are no conditions proposed which require that the licence is limited in this way and the premises are immediately underneath the bedroom windows of elderly residents. We therefore believe that the grant of the licence, without conditions to ensure that it is only used in the way intended, will fil to support the Licensing Objective of the prevention of public nuisance. We therefore ask that you refuse the grant of the licence as applied for.

The CGCA's view is that with the following conditions added to the Licence it would be able to support this Licensing Objective.


Proposed Condition	Reason
The sale of alcohol is at all times ancillary to the use of the premises as an art gallery and can only be made to customers holding tickets to visit exhibitions at the gallery	This is to ensure that the premises cannot be used as a bar, with any artwork incidental to the experience
The capacity of the premises is limited to 20 customers at any time	There are 2 reasons to limit the capacity, one is to reduce the risk of disturbance and the other is because it is in a basement with a single means of escape.
No alcoholic beverages or glass containers shall be taken outside the premises by customers at any time.	To ensure customers do not gather outside to finish their drinks
Customers smoking on the public footway shall not be permitted to cause obstruction of the highway to passers-by and smoking must not take place immediately outside the premises	The pavement is not wide enough for smokers to congregate and smokers need to be kept away from the windows of residents above.
No noise generated on the premises, or by its associated plant or equipment, shall emanate from the premises nor vibration be transmitted through the structure of the premises which gives rise to a nuisance.	An immersive experience could also include audio and it is appropriate to ensure that noise is not transmitted through the structure to the residential properties above.

We hope that this representation is clear and ask that you advise us well in advance of any meeting at which this application will be discussed.

**Details of representation** 

I am a Drury Lane resident and I value well-run local businesses on the street.

Accordingly I am in support of there being an art gallery at 185 but I am not in favour of the proposed seven day a week alcohol licence. My reasoning is as follows: - The Drury Lane district already has a number of drinking establishments, and others are planned. Another drinking establishment would push the already delicate balance between the leisure industry and local residents further against the interests of residents. - The gallery is directly below

social housing units - some occupied by vulnerable people. These units already experience significant crime and anti-social behaviour. Stukeley Street is well-known as somewhere drug users and rough sleepers congregate. The potential addition of all-day drinkers will do nothing to turn around the deterioration of this part of our neighbourhood. - It is highly likely that smokers using the gallery will smoke directly beneath the flats in Drury Lane and those in Stukeley Street. Neighbours already find it difficult to escape secondhand smoke from the cafe below their flats and the large congregations of smokers attending the nearby International School and local offices. - People are likely to congregate on the already congested narrow footpath on Drury Lane. A compromise arrangement might be supportable if: - the alcohol licence was wholly and firmly tied to those times when the there is a genuine exhibition in place. (The fear is that a full licence might become a cover for a drinking establishment) - A door policy inhibits any possibility that drinks may be taken outside. - A door policy robustly enforces that no smoking takes place anywhere near a residential part of Drury Lane or Stukeley Street. - The staircase leading to the basement is soundproofed to the same standard as the rest of the premises.



#1 Pizza Ecco has a late alcohol license and is situated next door to 185 Drury Lane. Within a few yards of 185 all of the following have alcohol licences: White Hart pub, 191

Drury Lane, Drop at 175 Drury Lane, Comedy Club 170a Drury Lane, The Sun Pub 21 Drury Lane and Travelodge 10 Dury Lane. Our block is surrounded by establishments with alcohol licences and residents already suffer from disturbance. public disorder and drunkenness as a result. #2 The street by 195 Drury Lane is very narrow, serving alcohol from 11am, 7 days a week will impact public safety. #3 There are disabled, ageing residents directly above the entrance of 185 Drury Lane, our homes will suffer from the nuisance of smoking below our windows, chatting below our windows and alcohol induced high spirits. We will get no peace from this because the licensing hours are from 11am to 9.30pm - 7 days a week. Our Right To Quiet Enjoyment will be severely and adversely impacted. The gallery is small and below ground in a basement without light - the gallery can be walked through within 5 mins, so there is no need for visitors to buy alcohol on the premises when it takes only 5 mins to enjoy the gallery. Indeed serving alcohol from 11am onward will simply attract people who want to drink all day. #4 St Joseph's Primary School, Macklin St, WC2B 5NA is 1 minutes' walk from 185 Drury Lane. Children and parents with prams pass 185 Drury Lane to collect and drop off their small children. Children will be forced to squeeze past alcohol drinkers and smokers at a very narrow section of pavement. It is a potential H&S issue because drinking will start from 11am - on Monday to Friday which are school days. There are many alternative establishments for drinkers and

smokers a few yards from 185 Drury Lane - adding yet another drinking establishment that adversely impacts residents, local people and passers by is unwarranted, unwanted and unnecessary. Please note 185 entrance is directly below x4 Goldsmith Court bedroom windows. Affected residents are: two individuals in their 80's and two individuals who are disabled.



#### Conditions consistent with the operating schedule

- Staff Training All staff responsible for selling alcohol shall receive induction and/or refresher training (at least annually) commensurate with their role and responsibilities in relation to the sale of alcohol and the times and conditions of the premises licence.
- 2. Training shall include the requirement and process for completing both the incident log and refusal log (detailed below), will be documented, and training records will be kept at the premises.
- 3. Training records shall be made available to the Police and/or Local Authority upon request and shall be kept for at least one year.
- 4. Alcohol Sales Customers temporarily leaving the premises (e.g. to smoke) will not be permitted to take drinks out of the premises.
- 5. Refusal Log A record of refused sales, which may be written or electronic, shall be maintained and completed with the time and date of the refusal and the name of the member of staff refusing the sale.
- 6. This record shall be made available to Police and/or the Local Authority upon request and shall be kept for at least one year from the date of the last entry.
- 7. Incident Log. An incident log must be kept at the premises and must be retained for a period of 12 months from the date an incident occurred. The log must be made immediately available on request to Police or an 'officer of a responsible authority', and must record the following:
  - a. all crimes reported to the premises (where relevant to the licensing objectives)
  - b. all ejections of patrons
  - c. any complaints received (where relevant to the licensing objectives)
  - d. any incidents of disorder any visit by a relevant authority or emergency services, noting time, date and purpose of the visit and the officer names.
- 8. All requirements and responsibilities pertaining to the lawful and responsible operation of the premises covered by primary legislation, will be complied with e.g building regs, health and safety, fire prevention.
- 9. The premises licence holder will operate the business with general consideration in respect of the neighbouring properties. Clear and prominent notices will be displayed in any outdoor public area, and at the exit, requesting patrons be quiet and have consideration for neighbours in the vicinity.

- 10. Age Verification Scheme Challenge 25 A challenge 25 age verification scheme will operate at the premises whereby any person who appears to be under 25 years of age, and unknown to the staff member serving as a person over 18 years of age, shall not be served alcohol unless they provide identification to prove they are over 18 years of age.
- 11. Acceptable forms of identification will be a valid passport, a valid photo ID driving license or a valid proof of age scheme card with the PASS approved hologram. Appropriate signage advertising the operation of the Challenge 25 scheme must be displayed in the vicinity of all points of sale for alcohol.

#### Additional conditions agreed with Police

- 12. The sale of alcohol shall only be legitimate whilst the permitted use of the premises for planning purposes remains that of a museum / gallery.
- 13. Alcohol sales will be ancillary to the main purpose of the venue which is a museum / gallery.
- 14. The number of persons permitted in the premises at any one time, excluding staff shall not exceed 60 persons at any one time.
- 15. The consumption of alcohol on the premises shall cease at 2200 hours.
- 16. Patrons permitted to temporarily leave and then re-enter the premises, e.g. to smoke, shall not be permitted to take drinks or glass containers with them.
- 17. Police must be called to all incidents of crime and/or serious disorder.
- 18. The CCTV system shall be maintained in good working order and at all times the premises is open to the public, be fully operational covering all internal and external areas of the premises to which the public have access. The CCTV camera views are not to be obstructed.
- 19. CCTV recordings must be concurrent with accurate time.
- 20. At least one CCTV camera is to be placed no more than seven feet above floor level; near to the exit in order to capture clear facial images of all persons leaving the premises.
- 21. The medium on which CCTV images are recorded shall be of evidential quality; stored securely; shall be retained for a period of 31 days; and be available for inspection by the Police or Local Authority upon request with 48 hours.

- 22. At all times when the premises are open for the purposes of licensable activities, a suitably trained member of staff shall be present to assist the Police or an authorised officer of the Licensing Authority in obtaining the CCTV footage.
- 23. The facility to transfer the images to a compatible, removable format, shall be held on the premises.
- 24. At least one Staff working at the premises at any one time shall be trained in the use of CCTV and a log will be kept to verify this.
- 25. Signs must be displayed in the customer areas to advise that CCTV is in operation.
- 26. If the CCTV is inoperative or not installed and working to the satisfaction of the Police, then within 48 hours the Police shall be notified and an estimate given of the repair timescale. The premises shall comply with all reasonable requests from the Police.
- 27. A Challenge 25 policy will be enforced, where any person reasonably looking under the age of 25 shall be asked to prove their age when attempting to purchase alcohol and signs to this effect will be displayed at the premises. The only acceptable forms of identity will be those with photographic identification documents recognised in the Home Office guidance; including passports, photo-card driving licence or proof of age card bearing the PASS hologram.
- 28. Staff training records shall be available for inspection by authorised officers of the licensing authority, officers of the trading standards service and officers of the Police.

#### Additional conditions agreed, following mediation with CGCA:

- 29. Alcohol sales are restricted to people who have purchased tickets for exhibitions in the space.
- 30. The licence holder will use his best endeavours to discourage customers smoking on the public footway immediately outside the premises and to ensure that the pavement is not obstructed.

#### Section 1: Background comments of the Borough Solicitor

- 1.1 The purpose of Camden's Statement of Licensing Policy is to make it clear to applicants that wider considerations will be taken into account when determining applications. It is intended to guide the Licensing Panel when considering licence applications. However, the Licensing Panel must always consider each application on its own merits and allow exceptions to the normal policy where the circumstances of the application justify allowing an exception. The burden is on the applicant to show that they comply with the policy.
- 1.2 Members should only address those matters that have formed the subject matter of relevant representations. Matters that arise that are not the subject of relevant representations fall outside the function that the Panel is exercising when it holds a hearing
- 1.3 Members must determine, having regard for the evidence, whether granting the application for a premises licence will impact adversely on the policy criteria listed in paragraph 3 of this report.
- 1.4 In accordance with the provisions of Part 1 of Schedule 5 of the Act, where a Licensing Authority rejects in whole or in part, an application for a new premises licence, the applicant may appeal against the decision, to a magistrate's court within 21 days of being notified of the decision.
- 1.5 Similarly, where a person who made relevant representations in relation to the application contends that the licence ought not to have been granted, or that different or additional conditions should have been imposed on the licence, he may appeal against the decision to a magistrate's court within 21 days of being notified of the decision.
- 1.6 The Human Rights Act 1998 incorporates the key articles of the European Convention on Human Rights into domestic law. Decisions on licensing matters are actions of a public authority and must be compatible with Convention rights. Consequently, Members of the Panel must be aware of the rights contained in the Convention (particularly those set out below) when making licensing decisions.

# (a) Article 6: Right to a fair trial

In the determination of his civil rights and obligations, everyone is entitled to a fair and public hearing within a reasonable time by an independent and impartial tribunal established by law.

(b) Article 8: Right to respect for private and family life Everyone has a right to respect for his or her private life, his home and correspondence.

(c) Article 1 of the First Protocol: Protection of property
Every natural or legal person is entitled to the peaceful enjoyment
of his possessions, including a licence. No one shall be deprived of his
possession except in the public interest and subject to the conditions
provided for by law and by the general principles of international law.

#### (d) Article 10: Freedom of Expression

Everyone has the right to freedom of expression. This right shall include freedom to hold opinions and to receive and impart information and ideas without interference by public authority and regardless of frontiers. This Article shall not prevent States from requiring the licensing of broadcasting, television or cinema enterprises.

The exercise of these freedoms since it carries with it duties and responsibilities may be subject to such formalities, conditions, restrictions or penalties as are prescribed by law and are necessary in a democratic society, in the interests of national security, territorial integrity or public safety, for the prevention of disorder or crime, for the protection of health and morals, for the protection of the reputation or rights of others, for preventing the disclosure of information received in confidence, or for maintaining the authority and impartiality of the judiciary.

#### (e) Article 14: Prohibition of discrimination

The enjoyment of the rights and freedoms set forth in this Convention shall be secured without discrimination on any ground such as sex, race, colour, language, religion, political or other opinion, national or social origin, association with a national minority, property, birth, or other status.

1.7 When formulating policy local authorities must have regard to the **Equality Act 2010**. The Act provides protection from discrimination in respect of certain protected characteristics, namely: age, disability, gender reassignment, pregnancy and maternity, race, religion or beliefs and sex and sexual orientation. It places the Council under a legal duty to have due regard to the advancement of equality in the exercise of its powers including licensing powers. Members of the panel must be mindful of this duty when determining all licensing applications.

#### The section 149 Public Sector Equality Duty

- (1)A public authority must, in the exercise of its functions, have due regard to the need to—
- (a) eliminate discrimination, harassment, victimisation and any other conduct that is prohibited by or under this Act;
- (b) advance equality of opportunity between persons who share a relevant protected characteristic and persons who do not share it;
- (c) foster good relations between persons who share a relevant protected characteristic and persons who do not share it.

- (2) A person who is not a public authority but who exercises public functions must, in the exercise of those functions, have due regard to the matters mentioned in subsection (1).
- (3) Having due regard to the need to advance equality of opportunity between persons who share a relevant protected characteristic and persons who do not share it involves having due regard, in particular, to the need to—
- (a) remove or minimise disadvantages suffered by persons who share a relevant protected characteristic that are connected to that characteristic;
  (b) take steps to meet the needs of persons who share a relevant protected characteristic that are different from the needs of persons who do not share it;
  (c) encourage persons who share a relevant protected characteristic to participate in public life or in any other activity in which participation by such persons is disproportionately low.
- (4) The steps involved in meeting the needs of disabled persons that are different from the needs of persons who are not disabled include, in particular, steps to take account of disabled persons' disabilities.
- (5) Having due regard to the need to foster good relations between persons who share a relevant protected characteristic and persons who do not share it involves having due regard, in particular, to the need to—
- (a) tackle prejudice, and
- (b) promote understanding.
- (6)Compliance with the duties in this section may involve treating some persons more favourably than others; but that is not to be taken as permitting conduct that would otherwise be prohibited by or under this Act.
- 1.8 In determining any application, the Council must comply with the public sector equality duty in s.149 of the 2010 Act. This is a duty to have regard to the need to achieve the statutory goals of s.149, rather than to achieve a particular result. The s149 duty sits alongside and does not override statutory requirements in relation to determining licensing applications, including the duty to consider all evidence on its merits and the legislative criteria listed at paragraphs 3 & 4.
- 1.9 When members have before them representations or other material on issues relevant to s149, even outside the scope of "standard" licensing considerations such material must still be specifically assessed in the context of s149. However, because s149 creates a requirement to "have regard" the fact a matter raised is relevant to s149 will not automatically translate into a reason for refusing an application that would be sustainable in any subsequent appeal, given the legal requirement to determine applications in compliance with licensing legislation.
