Public entertainment by way of music and singing only provided solely by the reproduction of recorded sound can only be provided during the hours that the sale of alcohol takes place.

#### **Additional Licensable Activity:**

#### a) Live Music

18:00 – 00:00 Friday and Saturday

These hours are extended from the end of permitted hours on New Year's Eve to the start of permitted hours on New Year's Day.

#### b) Performance of Dance

18:00 – 00:00 Friday and Saturday

These hours are extended from the end of permitted hours on New Year's Eve to the start of permitted hours on New Year's Day.

#### c) Late Night Refreshments

23:00 – 23:30 Monday to Thursday

23:00 – 00:00 Friday & Saturday

These hours are extended from the end of permitted hours on New Year's Eve to the start of permitted hours on New Year's Day.

## **Variation to Existing Licensable Activity and times:**

#### d) Supply of Alcohol (For consumption on the premises)

12:00 – 23:30 Monday to Thursday

12:00 – 00:00 Friday to Saturday

12:00 – 22:30 Sunday

These hours are extended from the end of permitted hours on New Year's Eve to the start of permitted hours on New Year's Day.

# 3. Policy

- 3.1. The licensing objectives engaged by this application is:
  - a) The Prevention of Public Nuisance

3.2. The premises are not situated in either cumulative impact policy area where there is a presumption to refuse all new or variation applications. The presumption is rebuttable.

Hours Policy (Chapter Five – Pages 36 - 38 of the Policy):

3.3. The hours policy is engaged by this application in relation to the proposed end times for licensable activities. The framework hours are given in the Policy as:

#### On Sales

Monday to Thursday 10:00 until 23:30 Friday and Saturday 10:00 until midnight 11:00 until 22:30

#### No sale or supply of alcohol

Monday to Thursday 09:00 until 23:30 Friday and Saturday 09:00 until midnight 09:00 until 22:30

3.4. The times for framework hours on any given day are not (and should not be regarded as) the 'usual' or 'normal' hours for licensable activities in the Borough. Instead, the framework hours serve to identify those cases where

the Licensing Authority will pay particular regard to the likely effect on the local neighbourhood of carrying out the proposed licensable activities.

- 5.4 Members are reminded that all applications must be considered on their own merits, and that findings on any issues of fact should be on the balance of probability.
