Notes on Completing the Form

This Form should be completed by Members and Co-opted Members (as defined in the Councillor Code of Conduct).

Statutory Disclosable Pecuniary Interests

Members must declare any Statutory Disclosable Pecuniary Interests within 28 days of becoming a councillor. Members can also use this form to notify the Borough Solicitor of any Statutory Disclosable Pecuniary Interests, which arise during their term in office.

Members must declare both:

- their Statutory Disclosable Pecuniary Interests; and
- the Statutory Disclosable Pecuniary Interests of their spouse or civil partner, a person with whom they live as husband or wife, or a person with whom they live as if they were civil partners (should they be aware that that other person has the interest).

If re-appointed as a result of re-election, Members must declare any Statutory Disclosable Pecuniary Interests not previously entered within the register.

Non-Pecuniary Interests

Members should use this form to disclose Compulsory Registerable Non-Pecuniary Interests and Voluntary Registerable Non-Pecuniary Interests as defined in the Councillor Code of Conduct.

Sensitive information

Where Members believe that the nature of their interest (pecuniary or non-pecuniary) is such that they consider that disclosure of the details of the interest could lead to receiving threats of violence or intimidation, such information shall be discussed directly with the Borough Solicitor.

Gifts and hospitality

Members shall declare any gifts, benefits or hospitality with an estimated value in excess of £25, accepted as a Member in the last four years, from any person or body other than Camden Council. Any gifts or hospitality received subsequently, which require registration, should be registered within 28 days of acceptance or receipt or acceptance. This should therefore ensure that Members' registers of interests contain declarations of all gifts and hospitality received during the current and immediate previous terms of the Council.

Submission

The Council encourages Members to keep the register up to date and therefore upon becoming aware of any new interest or change to any interest specified above, Members are encouraged to register details of that new interest or change by providing written notification.
