

APPENDIX A – FEES AND CHARGES SUPPORTING INFORMATION

This report delegates authority for approving fees and charges increasing by up to 7% to the relevant Executive Director in consultation with portfolio holders. New fees and charges or exceptions where increases are above 7% on the previous year's maximum level are detailed for Cabinet approval.

Supporting information is provided below to explain the exceptional proposals and the reasonableness of the fee or charge.

A number of fees and charges for 2025/26 were set as part of the Parking Policy Review in February 2024, or as part of the Update on the Council's Medium Term Financial Position in July 2024. No further decisions are sought on these.

Digital and Data Services

Contact Camden

The majority of the changes proposed for fees and charges in Contact Camden (CUS.022, CUS.040, CUS.046-047, CUS.053, CUS.056, CUS.059, CUS.061, CUS.065, CUS.067-072) are due to changes in statutory fees set by central government. It should be noted that the Registration of Births, Deaths, Marriages and Civil Partnerships (Fees) Regulations 2016 (as amended) contain provisions permitting a discretion to reduce, waive or refund part or all of the specified fees on the grounds (a) that requiring payment of the fee would cause hardship to the person required to make payment (b) of compassion; or (c) of error otherwise than on the part of the person required to make the payment. This discretion cannot be applied to fees under Regulation 3A (transmission of part of fees to Registrar General without the consent of the Registrar General). Any decision on the reduction, waiver or refund of fees will be taken in accordance with the applicable statutory provisions. There are also some changes to discretionary fees (CUS.064, CUS.066) for booking appointments.

A new fee (CUS.240) is proposed for dressing room hire. The service is also introducing Here's to You reception packages, which are set packages and can be customised. The starting fee (CUS.241) is recommended for approval here.

One fee for combined ceremony room hire (CUS.216) is proposed to increase by more than 7%, which recognises the costs of room set-up, officer time and the use of a larger room for ceremonies.

It is proposed that the cost of two birth certificates after re-registration (CUS.233) is increased from £22 to £25. The service's general postage fee (CUS.062) is recommended to be increased by 30.43% to cover stamps and envelopes.

Economy, Regeneration & Investment

Planning

The planning service is recommending the introduction of two new administration fees. These new charges are being introduced for processing refunds, with REG.200 based on 2% of the highest-valued statutory application fee and REG.201 based on 2% of the highest-valued pre-application fee respectively. Actual fee income may be less depending on the type of application fee requested by the customer.

The proposed fee for each additional search carried out on a parcel of land as part of the official Local Land Charges search of the register LLC1 (REG.065) has been uplifted to a round £1.50. The fee has been benchmarked against Islington who charge £2.

Environment & Sustainability

Environment Services

New discretionary Street Trading fees (STR.001-005) have been introduced to incentivise early payment of statutory Fixed Penalty Notices (FPNs) for street trading offences. These fees have been introduced to reflect the early repayment option (which was not previously separated out in the fee structure) and have been introduced for transparency.

Whilst most commercial waste charges are increasing by less than 7%, it is proposed that the Slim Jim bin charge for business glass collection & disposal (PLA.0331) is increased by 8.19%. This charge covered a new service introduced in 2024/25 and the proposed increase is to ensure cost recovery.

Parking Operations

The proposed parking permit fees (CUS.104, PCUS.087, PCUS.089, PCUS.133-150) relate to 6 month permits. These are calculated based on the annual permit fees which were agreed as part of the February 2024 Parking Policy Review.

Public Safety

Public Protection

The licensing service are seeking to introduce new discretionary fees (PRA.001-003). Each charge takes into account cost recovery and has been benchmarked against Westminster City Council.

It is proposed that statutory fees for explosives licenses (PLA.0749-0771) are increased in line with the maximum permitted statutory fee limit.

It is proposed that environmental searches fees for contaminated land (PLA.0917-0918) are increased by circa 10%. Benchmarking indicates that a 10% increase would place Camden's fees in the mid-range of those charged by London Local Authorities.

Benchmarking carried out on pest control charges (PLA.0533-0538, PLA.0540-0547) has resulted in the proposal to increase fees by circa 10%. Charges were compared with boroughs such as Brent, Lewisham and Barnet.

It is proposed that film licensing fees (PLA.0895, PLA.0897-0898, PLA.1017) are uplifted. These proposed charges are below the levels charged by Westminster, helping the service to recover costs whilst aligning with the Council's strategy to promote arts and culture within Camden.

Pavement licensing renewal or variation fees (PLA.0984) are recommended to be uplifted to reflect the new statutory cap.

Recreation

Green Spaces

Following benchmarking work for Padel charges carried by the service, new discretionary fees (PS.001-004) have been introduced. The padel charges benchmarking work reviewed charges levied in a number of other locations in London.

Sports and Physical Activity

It is recommended that charges for soft play parties (GLL.135-139 and GLL.141) are increased between 20.1% - 41.1%. This is mainly due to the improved product which will include party room hire. Exclusive hire parties have seen the largest increase, as the capacity of the new soft play structure at Swiss Cottage Leisure Centre more than doubled when completed earlier this year.

Talacre basketball fees (COM.482-484) are recommended to increase by more than 7%. These fees will remain lower than similar activities provided by some other providers.

An uplift of more than 7% is also suggested for girls football fees (COM.460, COM.494-502). This will support cost recovery (including by reflecting that fees should cover the cost of entering competitions) whilst also remaining lower than some other local clubs.

The existing Talacre trampolining fees (COM.471-473, COM.563) are proposed to increase by more than 7%. These fees are due to remain lower than those charged for some similar activities elsewhere.

It is proposed that the charges made for sports hall and sports pitch block bookings (GLL.046-047) are aligned with those for casual bookings. Block bookings get secured access for groups well in advance of the booking window for other customers. For those groups requiring support to deliver their activities, we will continue to provide a community discount for block bookings where relevant.

Each pre-paid leisure centre membership we offer includes a monthly and annual payment option, with the annual option generally representing a 10% discount against the monthly. The Disabled Annual membership (GLL.104) has drifted away from this 10% target, and currently sits at 15%. The uplift proposed for 25/26 brings the discount to 11%.
