Please accept my profuse apologies for below.

As you can imagine I had to prepare the Deputation in great haste & without consultation.

I am therefore withdrawing my legal points and same will not be raised as we decided it is not appropriate for the Legal Department to be asked to pursue them. I had not imagined the legal attachments would be circulated in full.

Instead I will make a short introduction and hand over to Joshua von Uexkull, a young YMCA member and casual worker, who will outline the services provided, as per my original Deputation. **We wish to propose below to the Committee, which please circulate:**

**We respectfully ask that this committee support the retention of these much loved, valued and vital amenities; that this committee recommend to the Cabinet that they:**

- 1. Publicly announce support for the campaign to save the Central YMCA;**
- 2. Use their influence to ensure these much-needed amenities are retained for the health and well-being of residents and visitors alike;**
- 3. In the event of the sale of the Central YMCA building being finalised that these same facilities remain open to the public;**
- 4. \*\* That officers' investigate whether the funding the Council made available to the YMCA at the time of construction had any conditions or covenants attached to that financial support.**

**\*\* It is my recollection that Camden assisted the YMCA financially as the costs spiralled as the average rate of inflation in 1976 was 16.77%, and 24% in 1975. In return all Camden youth workers (such as myself) were made honorary members of the Central YMCA, and there may well have been other conditions attached to Camden's financial support.**
