## 1. Introduction

- 1.1 The report outlines the Audit and Corporate Governance Committee's work plan for the 2025/26 municipal year as attached at **Appendix A** and invites the Committee to note and amend it as necessary.
- 1.2 In considering amendments to the work plan or scheduling training the Committee should have regard to its terms of reference as at **Appendix B**.
- 1.3 The Committee is also asked to note the action tracker for actions arising from the meetings in 2024/25 as set out at **Appendix C**.
- 1.4 Additionally, it has been previously agreed that the Committee should have regular sight of, and have regard to, the nine elements of the Chartered Institute of Public Finance Accountancy's (CIPFA) guidance on 'Evaluating the Effectiveness of an Audit Committee'. These are listed at **Appendix D**.

## 2. Work plan 2025/26

- 2.1 The structure of the work plan follows a similar pattern to previous years, comprised of reports that the Committee is required to take under its terms of reference, regulations or CIPFA guidance and reports the Committee has previously requested.
- 2.2 The Committee is asked to consider whether there are any other matters within its terms of reference that it wishes to add to the work programme for a future meeting.

## 3. Member Training

- 3.1. A programme of induction and training for Members of the Committee was agreed prior to the May 2022 elections based on the following principles:-
  - Focused on the key areas where Members might lack skills.
  - Arranged to be timely, so as to inform upcoming Committee decisions.
  - Where possible held immediately prior to Committee meetings.
  - No more than 45 – 60 minutes where possible.
  - Run by officers unless external expertise is needed.
- 3.2 The following sessions took place after the May 2022 elections:
  - Internal Audit and Anti-Fraud – Thursday 16<sup>th</sup> June 2022, 5.30-6.30pm (immediately before the Committee meeting)
  - Treasury Management – Tuesday 28<sup>th</sup> June 2022, 6.30-9.00pm
  - External Audit – Thursday 8<sup>th</sup> September 2022, 6.00-7.00pm (immediately before the Committee meeting)
  - Risk Management – Thursday 17<sup>th</sup> November 2022, 6.00-7.00pm (immediately before the Committee meeting)

- 3.3 The session held on the 8<sup>th</sup> September 2022 was abandoned part way through as the news came in of the passing of Her Majesty Queen Elizabeth II. The session was completed on 2<sup>nd</sup> November 2022 via Teams.
- 3.4 Refresher training on the key areas of work of the committee are taking place as follows:-
- Risk Management – Thursday 5<sup>th</sup> December 2024, 6.00-7.00pm (followed by the Committee meeting at 7.00pm) - done
  - Accounts and External Audit – Thursday 20<sup>th</sup> February 2025, 6.00-7.00pm (followed by the Committee meeting at 7.00pm) - done
  - Internal Audit and Anti-Fraud – Thursday 3<sup>rd</sup> April 2025, 6.00-7.00pm (followed by the Committee meeting at 7.00pm)

A session on Treasury Management will be scheduled before the July 2025 meeting.

- 3.5 Moving forward, a suite of training will be run every two years, with a full suite run as part of the post local election Member Induction programme, followed by a refresher suite run around the middle of the four year term of the Council. Members are of course free to request additional training at any time and officers will do their best to accommodate any such requests, particularly for new Members joining the committee mid-term.
