3.2 The premises is situated in the Camden Town special policy area where there is a presumption to refuse all new or variation applications. The presumption is rebuttable

Hours Policy (Chapter Five – Pages 36 - 38 of the Policy):

3.3 The hours policy is engaged by this application in relation to the proposed end times for licensable activities. The framework hours are given in the Policy as:

For licences not including the sale or supply of alcohol:

Monday to Thursday 09:00 am until 11:30 pm Friday and Saturday 09:00 am until midnight Sunday 09:00 am until 10:30 pm

3.4 The times for framework hours on any given day are not (and should not be regarded as) the 'usual' or 'normal' hours for licensable activities in the Borough. Instead, the framework hours serve to identify those cases where the Licensing Authority will pay particular regard to the likely effect on the local neighbourhood of carrying out the proposed licensable activities.

3.5. The Council has adopted a set of principles that commit our licensed premises to act in a responsible manner, taking all forms of female harassment seriously and set out the practical steps licensed premises can take to support this.
