<b>Prevention of Public Nuisance</b>	<p>The Policy has been revised to state that: <i>"The Licensing Authority is committed to the prevention of public nuisance and as such expect the operation of licensed premises not to create additional public nuisance so as not to interfere with the personal comfort or amenity of immediate neighbours or the nearby community."</i></p>	<p>Chapter 4 paragraph 4.53 Page 41</p>

<b>Framework Hours</b>	<p>The policy has been revised to state that:  <i>“Whatever the hours within which licensable activities are proposed, we expect the applicant to consider the risk and volunteer appropriate conditions in their operating schedule to promote the licensing objectives and in particular to prevent crime and disorder and public nuisance.”</i></p>	<p>Chapter 5, Paragraph 5.8  Page 47</p>
<b>Dispersal Policy</b>	<p>To strengthen the policy approach, this has been updated to include a requirement for reviewing dispersal policies whenever recurring issues arise during dispersal. This ensures a proactive response to ongoing concerns and promotes a safer, more orderly environment.</p> <p><i>“Given the significant role that effective dispersal policies play in reducing the risk of crime, disorder, and public nuisance as customers leave, it is expected that these policies are reviewed promptly whenever the Licence Holder becomes aware of any recurring issues related to dispersal.”</i></p>	<p>Appendix 3  Pages 85-88</p>
<b>Model Conditions</b>	<p>The model conditions have been revised to address specific issues. The total number of model conditions have been reduced from 194 to 138.
