### **Application**

- 1.1 This is an application for a new premises licence under section 17 of the Licensing Act 2003. **Appendix 2**
- 1.2 The application is for:
  - a) Sale of Alcohol (Off Premises Only)

09:00 - 23:00 Monday to Saturday 11:00 - 22:30 Sunday
```

## b) Opening hours

```
07:00 - 23:00 Monday to Saturday 08:00 - 22:30 Sunday
```

- 1.3 The applicant has agreed to accept a total of 34 additional conditions, requested by the Police, responsible authority and one condition from the Licensing Authority, responsible authority.
- 1.4 On the basis that the additional conditions have been agreed, the Police and Licensing Authority did not submit a representation. Correspondence can be found at **Appendix 2**.

### 2. Representations

- 2.1 Eight relevant representations were received in relation to the application.
- 2.2 The representation opposes the application, and are from a local Councillor and seven residents.

#### 3. Policy

### Hours policy (Chapter Five- Page 47 to 49 of the Policy)

3.2 The hours policy is engaged by this application in relation to the proposed start time for the sale of alcohol . The framework hours are given in the policy as:

## No sale or supply of alcohol

Monday to Saturday 08:00am until 23:30 pm Sunday 10:00am until 23:00 pm

3.3 The times for the framework hours on any given day are not (and should not be regarded as) the "usual" or "normal" working hours for licensable activities in the Borough. Instead, the framework hours serve to identify those cases where the Licensing Authority will pay particular regard to the likely effect on the local neighbourhood of carrying out the proposed licensable activities.

### Women's Safety (Chapter 4 – Page 30 to 32 of the Policy)

3.4 The Council has adopted a set of principles that commit our licensed premises to act in a responsible manner, taking all forms of female harassment seriously and set out the practical steps licensed premises can take to support this.

The principles encourage all licensed premises to consider and implement them in the day to day operation of their premises and include:

- a. Let's Communicate
- b. Supporting Each Other
- c. Training for All

The application does include these principles.
