Previously submitted 2 videos from 29/10/2025 Lebanese Grill Staff altercation with vehicle and driver in the street on 2 occasions.

The Lebanese Grill video of the street altercation inclusion.

This matter does not involve the cooking practices on the premises but more of a wider view of the behaviour of staff who twice approached vehicle in street and created disturbance.

There own licence conditions mention the added surveillance the premises will provide to the area to prevent issues arising. Ties in with the police attending the premises shortly after to speak to the driver in case they wish to press charges. Conditions 7, 9,11,13 issues of disorder, nuisance, sense of security. Essentially create a safe space.

Environmental Protection Act 1990 Licensing Act 2003

We have received a complaint, alleging that late night waste collections activity is causing a nuisance to neighbouring residents. There is also comment that YOUR CUSTOMERS are creating public nuisance when visiting your food premises late at night and loitering on the street outside. The Council has a statutory duty to investigate such complaints. Reported 28 May 2024, and Waste collection occurring midweek 23.30 – 00.00 midweek. Patron noise various up to 2am.

You may need to consider making alternative arrangements for collection between hours 7am and 9pm Monday to Friday. Also, with regards to patrons outside be mindful that your licence could be reconsidered under a LICENCE REVIEW, for a reduction the hours and activities, should public nuisance complaints and problems with the current opening hours.

Environmental Protection Act 1990

This legislation requires you to use the "best practicable means" (BPM) to counteract the effects of nuisance. You must take appropriate action to prevent further e nuisance. This includes measures such as:

- Technical improvements.
- Appropriate management procedures.
- Reasonable hours of operation.

Licensing Act 2003

This department may also instigate action under the Licensing Act 2003 to review a premises licence in cases of persistent public nuisance. As the Licence Holder/Designated Premises Supervisor you must ensure that the premises operate in accordance with the promotion of the Licensing Objectives, which are:

- 1. The Prevention of Public Nuisance
- 2. The Prevention of Crime and Disorder
- 3. Ensuring Public Safety
- 4. The Protection of Children from Harm

If we receive further complaints and are satisfied of the existence or likely recurrence of a statutory nuisance, we may serve a noise abatement notice under the Environmental Protection Act 1990. Breaches of the abatement notice may result in legal proceedings.

Hello,

I hope that you are doing well!

We have recently received a number of complaints related to smoke and odour emanating from your kitchen extraction flue. We attended last week and discussed the issue with your shift manager who advised that action has been taken and an engineer has been scheduled for this week. Please could you advise once the engineer has attended and any intended action that you are going to take and a proposed timescale.

Ideally, restaurants cooking on charcoal grills require high level mitigation usually including carbon filters and ESP system with regular servicing. Please could you advise what mitigation is currently in place with the system?


