#### APPENDIX A - FEES AND CHARGES SUPPORTING INFORMATION

#### A1. 2026/27 FEES AND CHARGES REQUIRING CABINET APPROVAL

This report delegates authority for approving fees and charges increasing by up to 7% to the relevant Executive Director in consultation with portfolio holders. New fees and charges or exceptions where increases are above 7% on the previous year's maximum level are detailed for Cabinet approval.

Supporting information is provided below to explain the exceptional proposals and the reasonableness of the fee or charge.

## Digital & Data Services

## **Contact Camden**

A number of new registrar fees (CUS.259, CUS.262-270) are proposed to align with statutory fees set by central government. These fees are already set out in legislation, and the service are now adding them to the fees and charges list to enable the provision of these services when required.

One exiting fee (CUS.216) for combined Ceremony Rooms 2 & 3 is proposed to increase by more than 7%. The proposed adjustment relates to the combined room of the Heath Suite and Primrose Room in the Town Hall to offer a larger ceremony.

## Recreation & Public Safety

#### Libraries

The service is recommending two new fees and charges (COM.612-613) to replace a single existing fee. This will allow for a clearer distinction between the charges for lost and damaged books for children and adults.

### Public Safety (Trading Standards)

The trading standards service is proposing to introduce two new fees and charges (PLA.1061-1062) in response to new legislation and regulations around vaping and tobacco. These charges (along with the costs of enforcement) would be issued upon breaches of compliance notices issued to traders under the Tobacco & Vapes Act 2024 and The Environmental Protection (Single-use Vapes) (England) Regulations 2024. As the Tobacco & Vapes Act 2024 has not yet taken effect, it is proposed to delegate authority to the Executive Director Investment, Opportunity & Place to introduce fee PLA.1061 once the Tobacco & Vapes Act 2024 comes into force.

## **Environment & Sustainability**

### **Environment Services**

A large number of discretionary fees (105 fees with references between PLA.0329-0398 and PLA.0848-1045) are proposed to increase by over 7% in line with the Veolia contract extension. These increases are due to contract cost increases (driven by pressures across areas such as staffing, fuel and vehicles), along with anticipated increased disposal costs. The proposed charges are designed to ensure cost recovery, capturing the full costs of collection and disposal. One new proposed fee (PLA.1067) also forms part of the business service within the Veolia contract and is set for cost recovery.

In addition, new fee PLA.1065 is recommended in respect of Fixed Penalty Notices for the obstruction of the highway, which can cover both electric hire bikes and other obstruction issues.

### **Parking**

Eight fees (CUS.075-076 & CUS.079-084) are recommended to increase by over 7% in the Parking service.

These are statutory fees, which relate to Penalty Charge Notices for contraventions of parking, moving traffic, and bus lane regulations. They also cover enforcement actions such as wheel clamping, vehicle removal to a pound, and associated storage or disposal charges.

London Council's Transport and Environment Committee is responsible for setting parking traffic and enforcement charges on borough roads, subject to agreement with the Mayor of London and the Secretary of State. This is under the Traffic Management Act 2004 (TMA 2004), Section 77 & Schedule 9 and Regulation 24 of Civil Enforcement of Road Traffic Contraventions 2022.

#### Streetworks

Four streetworks fees for fixed penalty notices under the Traffic Management Act (PLA.0259-0262) are recommended to increase by more than 7%. These are statutory fees, with the increase due to come into force in January 2026. This is designed to improve alignment with inflation and cost recovery for enforcing regulations. This approach will also involve higher fees to encourage efficient use of road spaces, and updated penalty charges for non-compliance.

It is also proposed to increase PLA.0264 by more than 7%, reflecting the need to coordinate emergency Traffic Orders at pace, which is done outside of standard timescales. This is also based on benchmarking data from surrounding boroughs.

## Economy, Regeneration & Investment

#### Culture

The Events Service are proposing to introduce a new fee structure for venue hire and events management services (COM.566-568, COM.570-609 & COM.614-615), in order to move from hourly rates to half day and full day rates. The team have conducted some benchmarking work with other councils and other indoor venues; many of whom are working with half day/full day hires and this change could potentially lead to generating more revenue. The venue hire fees cover indoor spaces across the portfolio (such as 5 Pancras Square, the Town Hall, Crowndale Centre and libraries) along with highways and untraditional spaces.

In addition, a new commercial leafleting fee (COM.569) is recommended which recognises the lower cost of leafletting in the public realm when compared to a commercial event. This should also make leafletting more financially viable for national charities and small local businesses, whilst enabling larger commercial businesses to book multiple days which can increase revenue.

## Planning (Land Charges)

Several existing land charges covering LLC1 and LLC Assisted Searches will now be processed by HM Land Registry and so will be recommended for deletion. It is recommended that the remaining land charge fees (REG.062, REG.064 & REG.066-068) increase by more than 7% in order to achieve cost recovery of the land charges service. This consist of two components, with a

37% increase reflecting cost recovery needs following the loss of LLC1 & Assisted Search income (which accounted for 27% of previous total income) as well as 3% for standard inflation, rounded up to the nearest 50p.

## Housing

## **Housing Services**

Two housing fees (HOU.035 & HOU.039) are recommended to increase by more than 7%. This change follows the recent renewal of the borough-wide Additional Licensing Scheme for Houses in Multiple Occupation (HMOs). The renewal was approved after a comprehensive review of the existing scheme, which showed clear improvements in housing conditions, particularly in areas such as fire safety, heating, sanitation, and ventilation.
