### 1. Application

2.1. Three relevant representations were received in relation to the application.

2.2. The representations oppose the application, and are from the Metropolitan Police, Responsible Authority, Public Health, Responsible Authority and a resident association and can be found at **Appendix 3**.

### 3. Policy

**Licensing objectives (Chapter Four, Pages 30 – 43 of the Policy)**

3.1. The licensing objectives engaged by this application are:

- a) The Prevention of Public Nuisance
- b) The Prevention of Crime and Disorder

**Hours Policy (Chapter Five, Pages 47 – 49 of the Policy)**

3.2. The hours policy is not engaged by this application in relation to the proposed end times for licensable activities. The framework hours are given in the policy as:

**For licences authorising the sale of alcohol for consumption off the premises:**

Monday to Saturday 08:00 am until 11:30 pm  
Sunday 10:00 am until 11:00 pm

3.3. The times for the framework hours on any given day are not (and should not be regarded as) the “usual” or “normal” working hours for licensable activities

in the Borough. Instead, the framework hours serve to identify those cases where the Licensing Authority will pay particular regard to the likely effect on the local neighbourhood of carrying out the proposed licensable activities.

- 5.4. Members are reminded that all applications must be considered on their own merits, and that findings on any issues of fact should be on the balance of probability.
