### ARCH TENANTS GROUP

Give the relatively recent election with a new government there was no new interaction with government official, noting also the change of name from DLUHC(Department for Levelling Up, Housing and Communities) to Ministry of Housing, Communities and Local Government.

The discussion on the topic of Right to Buy continue and we hosted some officials from Ministry of Housing, Communities and Local Government to listen to member's varying views:

- The Government committed in its manifesto to review the increased Right to Buy (RtB) discounts introduced in 2012.
- The Government has therefore started to review the increased RtB discounts that were introduced in 2012. As part of that review, it is engaging with stakeholders, including councils and tenant groups.
- The outcomes of the review and the secondary legislation to make the changes will be announced in the Autumn.

- The Government believes that RtB is an important route for council housing tenants to be able to buy their own home, but it wants to achieve a better balance,
- The RtB has had a major impact on council housing stock, with many of the homes sold not replaced.
- The RtB has impacted in particular on the levels of social housing for Social Rent and it has also reduced the motivation and confidence of councils to build.
