PURPOSE

This is the second of two sessions to consider **ELFT's Community Mental Health Transformation Programme** and its aim to create a more integrated and accessible system, bringing together GP practices, social care, and voluntary services to offer new models of care with community-based support and early intervention.

OUTLINE

At our 11 Nov meeting we received briefings from ELFT, Public Health, NHS NEL and Mind on:

- the scope of local mental health, local prevalence and the current support available
- ELFTs current offer detailing how people access their services and then move through the various care pathways.
- key drivers for ELFTs Transformation Programme - the current timelines and consultations
- The wider commissioning intentions in North East London and the work of the integrated mental health post

This meeting will move on to cover:

- ELFTs new offer and how it varies from the previous one
- What issues emerged from the consultations
- The Adult Social Care structure and approach for integrated mental health
- Particular challenges arising from the short term nature of funding and the current uncertainty of where future budget control might sit. e.g. Neighbourhoods level.
- How the offer will align with the Neighbourhoods Programme
- How the offer will align with the Adult Social Care provision
- How the offer will align with *NHS 10 Year Plan's* emphasis on digital in both the NHS App and ELFT's patient engagement app.
