Item 4 - Housing Support for Families of Children with SEND

Outline

In January 2025, families of children with SEND made a deputation to Full Council setting out their concerns in relation to accessing local housing support. Key issues identified by parents included:

- A more developed understanding of the needs of families with SEND and how this impacts on housing needs and requirements;
- Greater clarity as to how the needs of families of children with SEND are assessed in relation to accessing the housing register and related support;

Following meetings between the Chairs/Vice Chairs of both CYP Scrutiny Commission and Living in Hackney Commission (as this issue spans the remit of both) with Cabinet members, senior council officers and local parent representatives, it was agreed to undertake a joint scrutiny of this issue with a focus on:

- *LA housing duties and responsibilities for families with children with SEND;*
- *Nature /scale of the housing challenge supporting families of children with SEND;*
- *Medical needs assessment process;*
- *Available housing help to support families move into alternative suitable accommodation (swaps, PRS and out of borough):*
- *Coordinated council wide offer in the absence of local housing options (e.g. adaptations, Family Hubs, Disabled Children Service, Respite, Early Help CVS).*

To support the scrutiny of this item, members of the Commission have undertaken a number of engagement sessions with local impacted families:

- Site visit to 3 families;
- Focus group with 5 families.
