<b>SEND Transition post 18</b>	Are children being adequately prepared for transition? Disabled Children's Hub development.
<b>Families First</b>	Implementation of new children social care model, and early help provision. Pilot in April 2026 - can be reviewed?
<b>Children's Social Care Annual Report</b>	Deferred in 2024/25 - as this report is also taken at Corporate Parenting Board, Cabinet & Full Council. To be taken to note in February 2026
<b>Pupil Movement</b>	Feedback from 2023/24 was that the reports contain too much data to effectively scrutinise - and maybe to focus on one area. Will not be taken 2024/25 - but some of this data could be encompassed in the planned review on behaviour management.
