1 Recommendation

1.1 That the Audit and Risk Assurance Committee consider and comment upon the contents of Grant Thornton's report on the council's Oracle Cloud implementation.

2 Reasons for Recommendation

- 2.1 To inform the Committee on the contents of Grant Thornton's report on the council's Oracle Cloud implementation.
- 3 How does this deliver objectives of the Corporate Plan?
- 3.1 The work of the external auditors is an important element of the accountability and transparency of the council's finances in helping to support all of the council's objectives.



















4 Context and Key Issues

- 4.1 Grant Thornton the council's external auditors, included in their programme of work for 2023/24, a high-level overview of the council's Oracle Cloud implementation, assessing:
 - Revised project governance structures, budgets and resource plans;
 - System and user acceptance testing;
 - Data migration;
 - Security;
 - Go live planning;
 - Training; and
 - Business readiness and change.
- 4.2 Upon completion of their review, a report was prepared setting out a number of recommendations.
- 4.3 Following receipt of the report the council has continued to liaise with Grant Thornton and has prepared an accompanying Action Plan in order to track progress made against the recommendations.
- 4.4 Within the programme governance, there is a strict criteria in place to assess the council's readiness for go-live from both a technical and organisational perspective, including feedback from officers across the council and other partners. In July 2024 it was determined that such feedback pointed to the council not being quite ready to go live yet, and the Programme Board therefore made the decision to revise the timeline. This will allow programme and business teams more time to meet demand for training and user engagement, complete further testing and improve critical work in areas such as data collection, security and support. This will ensure everything is in place to make Go-Live as seamless a journey as possible. Therefore, the Go-Live dates have moved from July / August to September / October 2024.
- 4.5 As part of regular liaison, Grant Thornton have been briefed on the outcome of the recent Programme Board, where it was agreed to move the Go-Live date to September / October 24.
