#### 4 Context and Key Issues

# Black Country Consortium LTD

- 4.1 The Council's continued involvement with outside bodies can help to support the Council's Vision and encourage better understanding of local needs and viewpoints. Appendix 1 sets out the proposed nomination.
- 4.2 The Black Country Consortium LTD is currently undergoing liquidation with Rendle & Co. In recent years, appointments have been made on an annual basis.
- 4.3 Rendle & Co require Guarantee Members to make decisions regarding fees before the final closure of the company.

#### Health and Wellbeing Board – Constitution

4.4 The Health and Wellbeing Board is a formal statutory committee of the local authority, established under Section 194 of the Health and Social Care Act 2012, as a forum where political, clinical, professional and community leaders from across the health and care system come together to improve the health and wellbeing of our local population and reduce health inequalities.



4.5 Following changes to NHS structures in 2022, the Board has reviewed its membership. The Board's constitution has also been refreshed to recognise the membership changes and to support the efficient transition of business.
