1 Recommendations

For the reasons set out in the report, it is recommended that Cabinet:-

- 1.1 consider and either approve all, approve in part or do not approve any of the recommendations of Health and Adult Social Care Scrutiny Board in respect of the scrutiny review of Loneliness and Isolation in Sandwell as follows:-
 - a) that for any pilot schemes or trials aimed to reduce social isolation and loneliness consideration be given first to conducting them in Tipton and Wednesbury due to the identified need in those towns;
 - b) that information on support services, community groups and local events are publicised widely including in Sandwell's libraries, on the Council's website, on community notice boards, at pop-up stalls and via the Sandwell Herald and Health-related publications;
 - c) that the Council explore how they can support the community run their own sessions, based on their own interests, and how to get others to participate;

- d) that the Social Prescribing Strategy for Sandwell addresses the issues of loneliness and social isolation;
- e) that a training module on the Council's e-learning platform be developed for frontline staff members to raise awareness of Loneliness and Social Isolation, their signs and how to direct individuals to support opportunities;
- f) that the Assistant Director of Place Contracts, Projects, Strategy and Policy explore options to introduce 'Happy to Chat' benches within the borough's green spaces and parks.

2 Reasons for Recommendations

- 2.1 The Health and Adult Social Care Scrutiny Board commenced the scrutiny review into Loneliness and Isolation in Sandwell in the municipal year of 2022/23.
- 2.2 The Board established a working group to conduct the review which undertook substantial research to understand what initiatives in the public, private, voluntary and community sectors were effectively tackling systemic isolation.
- 3.2 At the meeting of the Health and Adult Social Care Scrutiny Board in March 2024 the Board agreed range of recommendations based on the research and findings of the working group. These recommendations are now presented to Cabinet for consideration.

However, the problem has been exacerbated since 2020, as a result of the measures put in place to limit the spread of covid-19.
- 4.2 Research so far by the Working Group has shown that many organisations across the public, private and voluntary and community sector are undertaking initiatives that try to tackle loneliness and isolation.
