1. Recommendations

- 1.1. To consider and comment upon the findings of the Scrutiny Spotlight Session in relation to the New Neighbourhood Model for Sandwell and approve the tabled recommendations as follows:
 - a) that the Assistant Chief Executive ensures that ward boundary changes are considered as part of the creation of the new Neighbourhood Services Team;
 - b) that the Assistant Chief Executive ensures that robust and demonstratable key performance indicators are used to assess the effectiveness of the new model, with clear deliverables within set timescales identified;
 - c) that the Assistant Chief Executive consults Sandwell's Members of Parliament and elected representatives when preparing ward plans;
 - d) that the Board receives a further update on the impact of the new Neighbourhood Services Team within six months of the vacancies being filled.

2. Reasons for Recommendations

- 2.1. The implementation of a new model of neighbourhood working is a key strategic priority for the Council in how it better responds to the needs of the communities it serves.
- 2.2. The input of the scrutiny function in overseeing the implementation of the new model provides appropriate accountability and transparency, as well as providing valued feedback to strengthen the delivery of neighbourhood working.

3. How does this deliver objectives of the Council Plan?

One Council One Team	The new model of neighbourhood working should directly assist in the delivery of high-quality inclusive services for all our customers. It will also contribute towards the objective of all our residents, including our children and young people, being active participants in influencing change – through being listened to and their opinions are heard and valued – within Ward Plans and Ward Priorities.
Living in Sandwell	The new model of neighbourhood working will contribute significantly to this objective through enhanced community engagement and the establishment of plans and priorities that will be focused on improving access to local services

4. Context and Key Issues

- 4.1. At the Board's meeting on 10 September 2024, it was agreed that it is to receive updates in relation to the new Neighbourhood Model for Sandwell.
- 4.2. On 17 December 2024, Board members attended a spotlight session to discuss the new Neighbourhood Model for Sandwell and made a number of recommendations to the Assistant Chief Executive.
- 4.3. In addition to the recommendations (above), Members present also requested a briefing note to be compiled in relation to the dedicated

communications support that will be part of the new Neighbourhood Working arrangements.

4.4. The Cabinet Member for Neighbourhoods and Community has oversight of and political accountability for the implementation of the new model of neighbourhood working. This remains one of the key strategic priorities for the authority and will continue to be a matter of interest to Cabinet and Scrutiny Members, as well as all Members in their ward councillor roles.
