#### 1 Recommendations

1.1 That the Board considers and comments upon the actions taken in relation to charging for Day Care Services post covid, and the proposal to recommence charges for Day Care Services from 7 April 2025.

#### 2 Reasons for Recommendations

- 2.1 To support the achievement of the council's medium term financial plan for 2025/26.
- 2.2 To ensure we have a consistent approach to charging for all community based services as those in receipt of other community based services have continued to be charged whilst those in receipt of Day Care Services only had their charges paused.

#### 4 Context and Key Issues

- 4.1 During the COVID-19 pandemic, day care services ceased buildingbased support, and some shifted to an outreach model. Consequently, charging for those receiving Day Care Services only was paused as care and support plans were not representative of the support received.
- 4.2 Since Covid, some providers have continued to provide a blended service which includes building based and community based activities. To charge people accurately it was necessary to commence a programme of reviews for those people receiving Day Care Services only. There were 267 people who required a review to be completed to determine their current needs and ensure that their care and support plans reflected the service received.
- 4.3 This activity was initially funded through Covid monies to support addressing the backlog in reviews and to enable the council to get to a position where charges could be reintroduced. Those receiving Day Care Services only were prioritised as non- residential charges would be unlikely to increase for those receiving other social care support as a financial assessment is completed by Community Care Business Unit (CCBU) to link relevant charges to disposable income.
- 4.4 The review process to determine current needs for support is ongoing and focuses on both those receiving support from our largest independent sector provider and from in-house provision. This is process is on-going and is due to conclude by the end of March 2025 with a view to enabling charges to be reintroduced for day services for those people

who are currently not paying for their services from 7 April 2025. This will provide equity with other chargeable services.

- 4.5 Financial assessments for those currently not being charged for services have commenced and are on-going. The CCBU have plans in place to complete financial assessments for 144 people.
- 4.6 Sandwell MBC spends more on day care provision than any of its neighbouring authorities. We currently purchase 46,000 days of support per annum at a cost of £5.7 million, supporting 394 people. A review of service provision is currently underway with a view to moving towards a Day Opportunities model which provides greater opportunities for people to live 'ordinary lives' in their own communities with less reliance on building-based provision and increased access to outreach support and community activities including volunteering and work opportunities as part of a strength based approach. This will include the promotion of the use of Direct Payments to support people to have more choice and control over the support they receive from a vibrant mix of Day Opportunities.
- 4.7 To support this move we aim to agree a new charging model for all Day Care Services. Revised fees have been negotiated with Options for Life who are the largest provider of Day Care Services for people with disabilities and this is the first step towards rationalising fees across the market. The new rates are banded to reflect the level of support a person needs which may be one to one, where a support worker is allocated to work with one person, or up to one to four where the support worker oversees a group activity. This will ensure that fee rates reflect the actual level of support required by individuals. In-house Day Care Services fee rates are set to match market rates so these new fee rates will also be used to assess charges for those attending in-house services. It is planned that this approach will form the basis of a framework to be used to review and reset charges for Day Care Services across Sandwell.
- 4.8 It is expected that the income from recommencing Day Care charges will be in the region of £336,000 per annum and this will support the medium term financial plan for 2025/26.
