3. Context and Key Issues

- 3.1 The Leading Healthier Places is the support offer from the LGA, providing tailored support to Health and Wellbeing Board Members via either a series of workshops or bespoke sessions to maximise assistance.
- 3.2 The LGA describes its support offer as 'an opportunity to refocus the purpose of the Health and Wellbeing Board, strengthen its role in the

- new system architecture and operate effectively in the new context of Integrated Care Systems.'
- 3.3 The support offer is provided by leaders and expert peers from across health and local government sectors to enable Health and Wellbeing Boards to achieve their strategic vision and objectives.
- 3.4 At its meeting on 12 June 2024 the Board decided to take part in the programme. Since that time positive progress has been made, as follows:-
 - a support agreement has been entered into, setting out the objectives and expected outcomes of the programme;
 - two advisors have been selected to lead the work, alongside the Chair and the Director of Public Health, both of whom have experience in the health arena and one with experience of chairing a health and wellbeing board;
 - an introductory meeting has taken place with the two advisors, the Chair and relevant officers to agree the approach;
 - the advisors have met (one to one) with the majority of Board members and are in the process of analysing and formulating constructive feedback;
 - a workshop for all Board members has been arranged for 7 April 2025.
- 3.5 All Board members are encouraged to make every effort to attend the workshop to ensure that all members benefit from the programme, leading to a strengthened Board.
