Chair's introduction

As Chair of the Licensing Committee, I am pleased to report on the work of the Licensing Committee and of the officers in Taxi and General Licensing which support the Committee's work.

The Council's Licensing Committee deals with many aspects of licensing and most of its work continues to be discharged on its behalf through delegated powers granted to officers.

Over the last year the Licensing teams have collaborated with partners to ensure license holders are complaint and meet their responsibilities.

Taxi licensing has seen a notable increase in the number of new driver applications, reflecting a renewed interest in the trade and the ongoing demand for licenced transport services.

General licensing has successfully conducted 202 targeted enforcement visits, reflecting our firm stance on compliance and our support for responsible licensing.

Looking ahead, we remain committed to upholding the principles of fairness, transparency and community safety that underpin our licensing objectives.

I would like to thank the team, our partners and all of those who have contributed to this important area of work.

Taxi Licensing

During the municipal year 1 April 2024 to 31 March 2025, the Licensing Committee considered 35 cases relating to the grant of new licence applications in line with the Private Hire and Taxi Licensing Policy and the renewal and review of existing licences. <u>NR3s Register</u> (National Register of Driver Refusals, Suspensions and Revocations)

From April 2023, each Licensing Authority was required to check all driver licence applications whether it be a new application or a renewal application against the National NR3s register. In the event that a decision is made to either suspend, refuse or revoke a driver licence on the grounds of public safety, then the driver details must be added to the National Register. Sandwell made the decision to add all refusals and revocations from 2018 onwards, with many of these decisions being made by the Licensing Sub Committee.

Enforcement Activity

The licensing enforcement team participated in 12 multi-agency stops that were organised by the Police within Sandwell and neighbouring authority areas. During these stops Sandwell licensed vehicles were checked for compliance with policy conditions.

During 24/25, a total of 206 complaints were recorded and investigated, complaints included accident damage to vehicles, standard of driving, drivers conduct and behaviour, alongside referrals from the police.

Policy Position

Scrap Metal Policy

The Scrap Metal Dealers Act 2013 ("the Act") gives the Council responsibility for the licensing of scrap metal dealers and enforcement of the licensing regime alongside the police. The General Licensing team has delegated powers to administer this function and to date, the council has administered the scrap mental licensing regime in accordance with the criteria set out in the Act. However, the council is developing its own policy to reflect the requirements under the Act.

The Act requires anyone who deals in scrap metal to obtain and display a relevant licence. The Act gives the police and local authorities more powers of entry, and inspection, as well as allowing a more thorough application process where licenses can be refused and subsequently revoked if dealers are deemed 'unsuitable.'

A policy for determining the suitability of an applicant for a scrap metal licence will be completed and in place by the end of this municipal year.

Statement of Licensing Policy

The Licensing Act 2003 requires every Council to have a 'Statement of Licensing Policy' which includes information outlined in the Secretary of State's Statutory Guidance to Licensing Authorities in England and Wales. The Council's Statement of Licensing Policy provides advice and guidance to the Licensing Authority when exercising its statutory functions as a Licensing Authority under the 2003 Act. The Policy is an essential tool to assist Responsible Authorities (mainly Regulators) and the Licensing Committee during the decision-making process to ensure that the decisions reached are sound, and robust enough to withstand an Appeal or judicial challenge. The Councils Statement of Licensing Policy has been reviewed, and a new policy was published in April 2025.

Gambling Act Statement of Principles

Sandwell's Gambling Act 2005 statement of principles was implemented in May 2022. The Gambling Act 2005 requires Sandwell Council, as the Licensing



Authority, to prepare a statement of principles to be applied when exercising the functions under the Act.

Section 349 of the Gambling Act 2005 ("the Act") requires licensing authorities, before each successive three-year period, to prepare a statement of principles that they propose to apply in exercising their functions under the Act, during that period, and to publish the statement.

An updated Statement of Principles has been produced and was published in April 2025.

Enforcement Activity General Licensing)

The General licensing team has worked closely with our partners to ensure ongoing compliance across all licenced premises. Collaborative efforts have focused on proactive engagement and regulatory compliance to ensure public safety. A total of 202 enforcement visits have been carried out across licensed premises, most premises were found to be compliant with follow up action taken where necessary.

Alongside enforcement visits, the team has supported Trading Standards on 50 underage test purchase exercises across the Borough and participated in the Councils Safer 6 campaign.

The team worked with HMRC on a programme of visits checking compliance with gaming machines in licenced premises. A total of 17 visits were conducted during 2024/25, advice and guidance was provided in order to bring the premises into compliance.



Looking Ahead

The Private Hire and Hackney Carriage Licensing Policy is due for review by 2027. Work has commenced to review the policy with the aim of this being completed by 2026.

General Licensing will conduct the necessary consultation and engagement to implement a Scrap Metal policy for Sandwell.

For General Licensing the team will seek to improve software systems to enable the introduction of an online function for the processing of licensing applications, creating efficiencies and an improved customer journey.

Concluding Remarks

The Committee conducts its role with a view to ensuring the public are kept safe from harm. In making its decisions, the Committee puts this perspective at the forefront of its decision making. This should provide further assurance to the public that the Council views the safety of its citizens as paramount in conducting this function.

Members and officers are constantly reviewing Council Policy and delegations to reduce committee time and further improve the level of service offered to license holder's alongside contributing to the Councils Corporate Plan.
