- To comment on the sections of the ICB Annual Report which describes the extent of their contribution to the delivery of Joint Health and Wellbeing Strategy.
- To give its opinion, as requested by NHS England on the ICBs level of engagement with the Board and on the JSNA and Joint Health and Wellbeing Strategy.
- To encourage persons who arrange for the provision of health and/or social care services in the area to work in an integrated manner for the purpose of advancing the health and wellbeing of the area.
- To work with partners to identify opportunities for future joint commissioning
- To lead the signing off the Better Care Fund plan
- To publish and maintain a Pharmaceutical Needs Assessment.
- To give its opinion to the Council on whether it is discharging its duty to have regard to any JSNA and Joint Health and Wellbeing Strategy prepared in the exercise of its functions.
- To exercise any Council function which the Council delegates to it
- To ensure strategic issues arising from Slough's Safeguarding Boards inform the work of the Board
- To receive the annual reports from Slough's Safeguarding Boards and ensure that partners respond to issues pertinent to the Board.
- 3.2 The informal working sessions will enable the Board to conduct its work programmes more effectively.
