This is 9% of the 11 car parking spaces provided and exceeds the DfT recommendation that 5% of car parking is designed for Blue Badge Users

This is **8%** of the **12** car parking spaces provided and exceeds the DfT recommendation that 5% of car parking is designed for Blue Badge Users.

And

SBC Transport Officers require the installation of 11 active electric vehicle charging points on site, providing 1 EV Charging Point per dwelling with a car parking space.

To (in **bold**):

SBC Transport Officers require the installation of **12** active electric vehicle charging points on site, providing 1 EV Charging Point per dwelling with a car parking space.

A total of 11 car parking spaces have been provided on site, which provides a ratio of 0.52 parking spaces per dwelling.
