1. Summary and Recommendations

- 1.1 This report sets out the proposed general fund fees and charges as part of setting the budget for 2025/26 and should be read in conjunction with the budget report on the same agenda.

Recommendations:

1. Cabinet is recommended to approve the proposed fees and charges on existing services to be implemented from 1 April 2025 as annotated on Appendix 1; and
2. Cabinet to note that a formal review of fees and charges including the fees and charges framework will be completed by July 2025 to ensure that fees and charges have been set appropriately.

Commissioner Review

"This report underpins the Council's principles of setting and annually reviewing fees and charges and as the Council moves through a programme of transformation, this will be subject to review to ensure that it continues to reflect the needs and aspirations of the Council.

A corporate approach to effective management of fees and charges will ensure that both the process and the fees themselves are transparent, fair, equitable and affordable. Price sensitivities of individuals and groups should be understood so that charges can be set appropriately to deliver the level of services necessary to achieve agreed objectives. Given

the financial position of the Council, subsequent to giving appropriate consideration to the above and the outcome of any consultation required, the Council should where appropriate seek to optimise funding streams over the period of the Medium-Term Financial Strategy to maintain core and priority services."

2. Report

Introduction

- 2.1 The council on an annual basis and as part of setting the budget reviews its existing fees and charges in line with the published [Slough Fees and Charges Framework](#). The framework is due for formal review.
- 2.2 This report considers the existing fees and charges schedule and proposes increases for executive functions with effect from 1 April 2025 and in consideration with the budget setting process for 2025/26. Fees and charges for non-executive functions will be considered by the Licensing Committee.

Options considered

Option 1 – approve fees and charges increases as proposed. Fees and charges have been reviewed and are to be increased in line with inflation or additional costs of service delivery. In some cases fees and charges are not to be increased by this level where there is concern that this will have an adverse impact on uptake. Some services are to undertake a more detailed review of service delivery costs and concessionary arrangements, including undertaking consultation where appropriate. These proposals will be submitted to Cabinet during the 2025/26 financial year and agreed as in-year arrangements. Fees subject to licencing committee approval will be presented to licencing committee for approval on 3 March 2025. **Recommended.**

Option 2 – increase all fees and charges by inflation. The Council has to comply with statutory frameworks for setting charges and some of these set out prescribed arrangements. In general when setting charges for discretionary services, the Council should secure cost recovery. The Council is not permitted to use fee setting as a tax raising function and therefore the Council should not set out to make a profit when setting discretionary charges. For some charges, the fee can be set at higher than cost recovery to meet the statutory basis, in which case there may be prescribed requirements as to what any surplus can be used for. It is therefore not appropriate to apply a blanket inflationary increase to all fees and charges. **Not recommended.**

Option 3 – do not increase fees and charges. For discretionary services, the Council's policy states it should secure cost recovery as a starting point and only offer concessions for clear policy reasons. If fees and charges do not cover costs, the additional cost is borne by the taxpayer. **Not recommended.**

Background

- 2.3 The existing framework sets out the following key principles for the setting of fees where fees and charges can be levied on service users and where permissible within relevant legislation:
 - a) Users pay for service at full cost recovery;
 - b) A strategic and informed approach to subsidy and concessions;
 - c) Adopting a strategic approach to new charges;

- d) Appropriate communication and engagement with service users;
- e) Coherence with broader efficiency and framework objectives; and
- f) Fees and charges will be subject to systematic and in depth review.

2.4 The approaches to setting fees and charges are described within the framework and summarised as follows:

- a) Full cost recovery. The council in most cases will adopt the Chartered Institute of Public Finance and Accountancy definition of total cost to calculate the fee or charge;
- b) Full cost recovery with concessionary discounts;
- c) Subsidised cost;
- d) Nominal – in that the service is provided and funded through general taxation; and
- e) Prescribed charging in that fees and charges are set nationally in accordance with appropriate legislation.

2.5 Whilst fees and charges are set annually, there is provision within the council's constitution to enable in year decisions taken by officers which are limited to inflation plus 3%.

Changes to proposed fees and charges

2.6 For fees and charges that are nationally set there is no increase in the current fees and charges set for the current financial year. For all other fees and charges, an increase is expected to be at full cost recovery as set out in the framework rounded up to the nearest 10 pence where practical to do so. A full list of fees and charges can be seen in appendix 1.

2.7 The next section provides a summary of proposed changes to fees and charges.

- a) **Adult Social Care** – Fees and charges schedule removes services no longer provided by the directorate such as Careline and day centre services. Deferred pay arrangements has been uplifted following the review undertaken in January 2025 including the addition of a new annual admin fee. All remaining fees and charges have been uplifted at 2.00%. A review of fees and charges for adult social care is being presented in a separate report for Cabinet. The proposals to amend the current policy will be subject to consultation with a view to a new policy being approved in April 2025;
- b) **Highways development, Planning and Building Control and Local Land Charges** – Where permissible fees and charges uplifted in line with full cost recovery of around 2.00% for most charges;
- c) **Hire of venues and sports pitches** - Where permissible fees and charges uplifted in line with full cost recovery of 5.00%;
- d) **Highways** – fee increase of 0.00%;
- e) **Highways and transport permits** – fee increase of 0.00%;

- f) **Parking** – Penalty Charge Notices fees are statutorily prescribed, parking permits, vouchers and dispensations have a fee increase of 0.00% and car park season tickets and on/off street parking will increase by 3.5%;
- g) **Waste services** – garden waste and bulky waste collection a nil increase; bin sales a fee increase between 2.00% – 3.00% dependent on bin type and waste disposal is a fee increase between 0.00% and 2.44% dependent on disposal type;
- h) **Allotments** – A review of fees and charges has been undertaken and a separate report is expected at March Cabinet for consideration;
- i) **Burials and Cremations** – variable fee increases of up to 10.00% where permissible;
- j) **Enforcement through fixed penalty notices** – various charges dependent on enforcement;
- k) **Licenses and registrations** – various charges based on licence or registration type where not statutory prescribed;
- l) **Mandatory licensing of houses in multiple occupation** – increases between 9.34% and 37.46%. This is for noting only and not Cabinet approval;
- m) **Food Safety** – fee increase of 0.00%
- n) **Trading standards** – fees increase of 2.08%;
- o) **Libraries** – 0.00% increase where charges are applicable with exception of per book reservation and request increasing from £3.00 to £4.00;
- p) **Children’s Centres** – These charges are set annually each September;
- q) **Blue Badge Scheme** – This charge is statutory prescribed; and
- r) **Weddings and citizenship** - Where not statutory prescribed have an average increase of 10.00%.

Benchmarking

- 2.8 As part of reviewing fees and charges, work has commenced on benchmarking our fees and charges with other councils. An initial view with two neighbouring councils and two statistical neighbouring councils on a selection of existing fees and charges suggests most charges are broadly comparable but there are some outliers that would be worth exploring as part of the reviews due in 2025.

Proposed new fees and charges

- 2.9 The proposed 2025/26 budget contains volumetric changes and a number of new fees and charges subject to following the council’s governance framework to introduce and total £3.397m. The risk reserve is there for any budget decisions subject to consultation where new fees and charges are not approved. These have not been included within the fees and charges schedule. The next table outlines the proposals:

3. Implications of the Recommendation

3.1 Financial implications

3.1.1 Financial implications have been set out in this report including the expectation that fees and charges must be set in accordance with the council's existing framework and where applicable on a full cost recovery basis so that it does not impact on the council tax payer. Where fees are nationally set there has been no change to budgets as national charges have not changed for 2025/26. Demand for services has assumed to remain static for 2025/26.

3.1.2 The table below provides a breakdown of existing budgets, price increase and revised budget for each Directorate.

3.1.3 Fees and charges represents 11.9% of the council's gross general fund revenue expenditure for 2025/26.

3.1.4 Given the recent announcement by government on council tax increases and impact on Slough, a formal review of all fees and charges will be undertaken during 2025/26. The Design Authority will review the outcome for each service before 31 July 2025 to ensure that fees and charges are appropriately set. In year changes will be approved subject to relevant governance process. Subsequently, fees and charges will be revised and changes implemented from 1 January 2025 and each subsequent year.

3.2 Legal implications

- 3.2.1 Some services the Council provides are mandatory and governed by specific legislation whilst other services provided are discretionary. Discretionary Services are those which the Council is permitted to provide but not required to provide.
- 3.2.2 In the absence of specific powers or prohibitions on charging for services, the Council has the power to charge for discretionary services under Section 93 of the Local Government Act 2003 and under the power of general competence found in Section 1 of the Localism Act 2011.
- 3.2.3 The overall position on charging is that the Council must not charge for a service if legislation prohibits it from doing so. If legislation places a duty on the Council to provide a service and to charge for it, then it should. The power to charge for discretionary services is not available to local authorities if there is a statutory duty to provide the service. For some services the power to charge is contained in the statute which permits the Council to provide the service. In this case, this specific power must be relied upon as opposed to the general power to charge.
- 3.2.4 Charges may be set differentially, so that different people are charged different amounts e.g. concessions for older persons or people with a disability or on low incomes. When considering whether to subsidise services or offer a concession, the Council must balance its fiduciary duty to general taxpayers with its responsibilities to service users and other overarching duties, such as its equality duties.
- 3.2.5 The Council must generally ensure that taking one financial year with another the income from any charges for a service does not exceed the cost of providing the relevant service, as the Council is not permitted to use its charging powers as a taxation power. Any surpluses or under recovery of income should be addressed through a regular review.
- 3.2.6 In the fees and charges appendix to this report, the column titled 'Basis for charging' indicates whether the fee stated is prescribed by statute (as a set amount or up to an amount) in which case it is noted as 'statutory prescribed' or 'statutory discretionary' where legislation provides that you may charge for providing a service but the amount of the charge is discretionary, within the remit of the legislation e.g. the charge may be limited to cost recovery, reasonable cost or based on consideration of prescribed matters, or as 'discretionary' which is where the authority is not obliged to provide the service but if it does so then the charges are based on cost recovery pursuant to the statutory power to charge in Local Government Act 2003/Localism Act 2011.

3.3 Risk management implications

- 3.3.1 In Directorates setting their fees and charges, consideration has been given to price increases and expected demand for services. There remains a risk that demand for services fluctuates and a review of costs may indicate that provision of services may not be at full cost recovery.
- 3.3.2 Reviews are expected to be undertaken during 2025/26 to ensure that fees and charges have been set appropriately and reflect changes to market conditions.

3.4 Environmental implications

- 3.4.1 There are no direct environmental implications contained within this report.

3.5 Equality implications

3.5.1 Section 149 of the Equality Act 2010 created the public sector equality duty. Section 149 states that:-

A public authority must, in the exercise of its functions, have due regard to the need to:

- a. Eliminate discrimination, harassment, victimisation and any other conduct that is prohibited by or under the Act;
- b. Advance equality of opportunity between persons who share a relevant protected characteristic and persons who do not share it; and
- c. Foster good relations between persons who share a relevant protected characteristic and persons who do not share it.

3.5.2 The relevant protected characteristics are age, race, disability, gender reassignment, pregnancy and maternity, religion or belief, sex and sexual orientation.

3.5.3 When making decisions in relation to service provision, the Council must take account of the equality duty and in particular any potential impact on protected groups.

3.5.5 A review of all fees and charges was undertaken to identify equality impacts. This table identifies potential impacts and recommendations made:

3.5.6 Fees and charges are set against a clear framework that seeks to ensure that an approach that is strategic, fair, economically and legally sound. By working within the framework, and implementing all changes to fees and charges in one cabinet paper any cumulative equality impacts can be identified. This framework also sets out the principles for any concessions which can be introduced to mitigate impacts. All proposed increases are to recover full costs in line with inflation increases. Any prescribed costs are in line with the requirement. It is also noted that a review of fees and charges for adult social care is being presented in a separate report for Cabinet and an EqIA has been submitted.

3.5.7 The Adult Social Care proposals have been reviewed under a separate equality impact assessment. Decisions to amend current policy will be subject to consultation with a view to a new policy being approved in April 2025. Particularly older people and disabled people have been identified through the EqIA. The consultation will identify if there are any further impacts on specific groups that have not been identified from the data reviewed. It is also recommended that proposals relating to cemetery and crematorium fees are subject to a separate EqIA as the changes could impact specific faith groups, due to the religious restrictions or requirements that determine whether someone is buried or cremated for example. Other impacts have been identified and it is recommended these are kept under review. These have also informed the cumulative impact assessment of the Budget for 2025/25.

3.5.8 The framework also requires that an Equality Impact Assessment is required to be carried out for all new charges to consider the likelihood of any disproportionate adverse impact on vulnerable groups. The new charges that are being introduced are listed under 2.9. Initial Equality Impact Assessments are required for these new charges to identify if there are any negative impacts, and if there are, a full impact assessment will be required.
