2. Report

Introductory paragraph

2.1 Announcements

- 2.1.1 Over recent weeks, NHS Frimley, along with all ICBs across the country, has been responding to national changes shaping the future of Integrated Care Boards. The recently released “Model ICB Blueprint” from NHS England sets a clear direction - focusing our role on improving population health, reducing inequalities and moving to a “strategic commissioning” way of working.
- 2.1.2 Across our region, plans are forming which would reduce the number of ICBs in the South East from six to four. This includes a proposal to bring together the NHS Buckinghamshire, Oxfordshire and Berkshire West ICB population with Berkshire East, currently served by us at NHS Frimley. We are also working with colleagues in Hampshire and Isle of Wight ICB and Surrey Heartlands ICB to consider proposals for the realignment of current Frimley boundaries to mirror those of emerging devolution proposals for local government.
- 2.1.3 Given the scale of change underway for all ICBs and NHS England, we are continuing to work with partners to explore how we can deliver services more efficiently at scale - cutting duplication and improving quality. This is a pivotal moment to shape a stronger, more collaborative future for our system and we will be seeking the ongoing views and involvement of our partners to help us get these changes right. We will continue to provide further updates in this newsletter.
- 2.1.4 During this time of change, it is critical that we do not lose sight of what we are here to do and the populations which we serve. We are proud of the important work which our teams continue to deliver, which improve quality, access and taxpayer value for the residents of the Frimley geography.

2.2 Current challenges and opportunities

- 2.2.1 **Carers as a priority group** - during this time of change, it is critical that we do not lose sight of what we are here to do and the populations which we serve. We are proud of the important work which our teams continue to deliver, which improve quality, access and taxpayer value for the residents of the Frimley geography.
- 2.2.2 Carers who provide unpaid care for someone who depends on them are considered a priority group for NHS Frimley ICB, recognising that carers keep people well and out of hospital but that they themselves also can have health challenges as a result of their caring role. The first face-to-face Frimley Health and Care Carers Steering group was held on Monday, 19 May. The importance of carers' health was discussed, and presentations were made on the support offers available. The meeting provides an opportunity for carers and professionals across Frimley to work towards co-producing good services and community offers for all carers across the system. It also provided space to share knowledge about what life is like for carers, showcase what works well for carers to keep them well and an opportunity to network.



2.2.3 Carers Week 2025 takes place from Monday 9th June to Sunday 15th June 2025. Throughout the week, events, campaigns, and activities will be organised in community settings to honour carers and provide them with practical advice and emotional support.

2.3 News from across the Frimley Health and Care System

- 2.3.1 **Hundreds turn out for heart screenings** - the Wexham cardiology team screened more than 250 patients in a single day this month at a Your Heart Matters health event in Slough. In collaboration with medical device company Medtronic and two heart valve charities, the team hopped aboard a specially adapted truck to offer free heart health checks to the local community.
- 2.3.2 People aged 50 and over were invited for a heart check-up with the Frimley Health team, including three cardiology consultants, two registrars and two specialist nurses. After filling out a medical history questionnaire, the patients were given a free consultation and, in some cases, an echocardiogram if any issues were identified.
- 2.3.3 The event saw a total of 256 people screened, with 15 echocardiograms completed showing moderate to critical issues in eight of those patients. Any patients requiring further investigation or treatment were referred via their GP for a follow-up appointment at Wexham Park Hospital. Slough MP Tan Dhesi and some of the local media came along to see the team in action. BBC TV London reported on the success of the event and interviewed Dr Navin Chandra, Consultant Cardiologist, who talked about the importance of raising awareness of heart valve disease.
- 2.3.4 **Staff join campaign against knife crime** - Nine doctors and nurses from Wexham Park Hospital have been helping over 200 students from Langley College to learn about the impacts of knife crime, and how they can help potentially save a life by learning some essential skills.
- 2.3.5 The initiative was driven by Dr Hussain Mahmood, a medical registrar at Wexham Park. Dr Mahmood collaborated with the Slough Youth Action community group, liaised with local police, and involved staff. Dr Mahmood said: "As a doctor who was born and raised in Slough, I feel a sense of responsibility to address all issues that face my community, whether it is health inequalities, drug abuse or social issues. "To address the issue of knife crime, I felt it was imperative I also involve my colleagues at Wexham Park Hospital, all of whom delivered excellent teaching on CPR and applying bleed kits. We were able to
