I hope you and the team are well. Please find the fare information requested below.

Local 2 mile journey
Saloon £7.00 minimum fare
Estate + £5.00
6 seat (Prius plus) + £10.00
6 seat XL (Alhambra/Sharan) + £15.00
6-8 Seat XL (LWB Vito/Tourneo/Vivaro) + £30.00

We are priced with fixed increments due to the limited availability of XL vehicles and the dead mileage of running the vehicle to cover local trips.

It works out cheaper to have 2x saloon vehicles for local trips or upto 10miles, XL vehicles work out cheaper for distance journeys 10 miles+ and keeps them available for i.e Airport transfer bookings.
