This application to review this premises licence is necessary, as Thames Valley Police believe that the Crime and Disorder Licensing Objective and Public Safety Licensing Objectives have been undermined. The Licensing objectives are being undermined as the PLH/DPS is continually breaching several of his conditions on the Premises Licence.

■■■■ has been the Premises Licence Holder and Designated Premises Supervisor since January 2025.

I have detailed below the incidents, visits and meetings relevant to this premises below:

**06/04/2025 - 01.21am**

Officers have attended the pub in relation to a missing person and observed people playing poker.

**16/05/2025 - 2225 - Breaches of Licence**

Breaches of Licence found during a Licensing check on the 16/05/2025 by the Police Licensing Officer:

Incident Register to be in place and kept up to date and made available upon the request of the Thames Valley Police and authorised Licensing Officers and be kept for a minimum of one year. No Incident Register could be shown

A Refusal book shall be kept at the premises and updated as and when required and made available for inspection on request to an Licensing Officers, Police or other responsible authority. No Refusals book could be shown.

Personal Licence Holder to be on site from 5pm until close every day. No Personal Licence Holder was on site at the time of our visit.

Minimum of 2 x SIA door staff to be on duty on a Friday and Saturday evening from 8pm until close and at any other time as advised by Thames Valley Police or the Local Authority. Door staff to be wearing high visibility jackets.

No SIA door staff were on site or working at the premises.

Any garden furniture to be removed at 10pm each day of the week. Garden furniture was still out.

**03/06/2025 - Licensing meeting**

Meeting held on the 03/06/25 for the breaches found on the 16/05/25 – Police Warning issued for 6 x breaches

**5/06/25 - Breach of Licence**

DPS did not attend pub watch meeting on the 05/06/2025 – details of the pub watch meeting were given to the DPS at the Licensing meeting on the 3/6/25

**01/08/25 –2316 Breach of Licence**

Breach found by PC 2582 during a visit on the 01/08/25 at 2316 – No doorstaff working

**07/08/25 - Breach of Licence**

DPS did not attend the pub watch meeting on the 07/08/25 – reminder letter also sent

**06/09/25 - 2155 Breaches of Licence**

Breaches of the Licence found by PC 7473 during a visit on the 06/09/25 at 2155 – No door staff working, No Personal Licence Holder on site.

Gen 40 dated 06/09/2025 refers

**30/09/25 – Licensing meeting**

DPS **failed** to attend the pre-planned Licensing meeting. Email sent to the DPS requesting he contact me by 1600 on Friday 3<sup>rd</sup> October 2025, failure to do so would result in a review of the premises licence. Contact made by the DPS following the email sent.

**02/10/25 – Breach of Licence**

DPS did not attend the pub watch meeting on the 02/10/25 – reminder letter also sent

**08/10/25 – Licensing meeting**

The PLH/DPS **failed** to attend second Licensing meeting at Slough Police station – Police Licensing Officer contacted the DPS on the phone and told him that a final meeting would be arranged for him to attend and that I would text him the details of the new time and date. I then reminded the DPS to ensure that all of the conditions on the Licence were being adhered to.

Licensing meeting arranged for 10.30am on Wednesday 15<sup>th</sup> October 2025 at Slough Police Station – details text to the DPS at 1149 am on 15/10/2025.

**11/10/25 – 2230 Breaches of Licence**

Breaches of the Licence found by PC 2855: No door staff working and garden furniture still out. Officer spoke with the DPS at the time of the visit.

**15/10/2025 – Licensing meeting**

Licensing meeting held at Slough Police Station with the PLH/DPS [REDACTED] PC 5689 McKee, PC 3931 Bartlett and the Police Licensing Officer. [REDACTED] was informed that due to the continual breaches of the Premises Licence, Thames Valley Police would now be applying to review the Premises Licence. He was again reminded to adhere to the conditions on the Licence

**17/10/2025 – 2230 Breaches of Licence**

Breaches of the Licence found by PC 5689 McKee, PC 6778 Moody and PC 8340 Saunders.

No Personal Licence Holder on site – No SIA door staff working – persons seen playing poker and smoking in the back room at the rear of the pub, which is accessible to the public.

Thames Valley Police believe that due to the continual breaches of this Premises Licence, the Crime and Disorder and the Public Safety Licensing Objectives have been and continue to be undermined.

Thames Valley Police believe that the Management of this premise, namely the Premises Licence Holder and Designated Premises Supervisor, [REDACTED] has complete disregard for the law and Authority and should be removed from the Licence with immediate effect.

Thames Valley Police request that the Premises Licence be suspended for a period of time to ensure that a new PLH and DPS is in place and all the current conditions are in place and are being adhered to. A full Licensing inspection to be completed by the Police Licensing Officer and Senior Licensing Officer, Slough Borough Council before the suspension is lifted.

We also request that the Licensing Sub Committee issue a 'Yellow card' to the licensed premises as a warning that if a further review is necessary and matters have not improved the Premises Licence may be revoked. A 'Yellow card' will be clearly and visibly displayed at the Premises for a period of 12 months detailing the imposition of new conditions on the Premises Licence and that this warning has been given.

PC 5689 McKee will be at the review hearing to support this application.
