### Nature of Incident – what happened?

Officers arrived at LA STUDY PUB and was greeted by a young Romanian man. Officers asked him if they had heard or seen anything. The young man went and got a man who appeared to be the proprietor of the premises.

Officers asked if we were allowed inside the establishment. The officers then went through the front of the establishment. The front door was unlocked. When officers entered in to the pub, it was rather dark, with not much light on. There was a man playing on a gambling machine. Officers did notice that they were drinks and glassware out in the open, showing that drinks were being served. The proprietor then led us to a room that was completely lit and it showed approximately 10 Romanian men playing poker.

Officers asked if they had heard anything, but they had not and they stated that they were all cousins and that it was a family event. Officers then went and searched the pub garden and nothing was there. Officers then left the scene.

### Nature of Incident – what happened?

SC Absalom and Debie Pearmain attended the premises to conduct a Licensing check - DPS not on site so spoke with the male who identified himself as the person in charge, [REDACTED] ( non personal Licence holder & brother of the DPS). Premises Summary was on display - CCTV date and time checked - 2/3 minutes out. I informed [REDACTED] that the outside garden furniture has to be removed each day of the week at 10pm - he then removed the furniture except for one table which was screwed down - advice given.

I asked [REDACTED] several questions in relation to the conditions on the licence but he was unable to assist.

The breaches identified during my visit were: No incident Register to be shown - No-one attending the local pub watch meetings - Refusal Book was unable to be shown - no Personal Licence Holder on site - No door staff were working - outside garden furniture was still outside at the time of our visit at 1025pm.

[REDACTED] told us that the venue was a Romanian Restaurant. [REDACTED] did speak to the DPS on the mobile phone whilst we were on site but we were unable to wait for the DPS as we had other visits to conduct.

I told [REDACTED] that I would contact his brother the DPS on Monday and in the meantime all of the conditions on the Premises Licence have to be adhered to. The pub was fairly busy with a lot of males drinking alcohol inside the pub and outside.

### Nature of Incident – what happened?

#### Premises Response – what part did staff play? How did they react/assist? (include good/poor performance)

Licensing meeting held at Windsor Police Station with ██████████ PLH/DPS, ██████████ Sagar, Senior Licensing Officer, SBC and Debie Pearmain, Police Licensing Officer. Meeting arranged to discuss the breaches of the Licence found by C3232 during the evening of the 16/05/2025.

██████████ was asked how long he had been at the pub and he told us that he had been there since October 2024. ██████████ was asked if he knew the conditions on the Licence & he told us he did.

Breaches found were: No Incident Register, no-one attending the local pub watch meetings, No Refusal Book could be shown, no Personal Licence Holder on site, No door staff working & the outside garden furniture was still outside.

Due to the breaches found ██████████ was issued a Police Warning and informed that if any further breaches are found or witnessed then the Premises Licence will be reviewed. Advice was given by Debie & ██████████ to ensure that all of the conditions are adhered to. ██████████ then explained the review procedure to ██████████ showed us details of a SIA Security Guard on his phone and told us that this guard would be working on Friday. ██████████ was reminded that the condition states 2 x SIA Security on a Friday & Saturday, so he must have 2.

██████████ was reminded that this is a serious matter and that ██████████ as the PLH & DPS should be aware of all the conditions on the licence so he must ensure that no breaches occur. ██████████ also confirmed that the CCTV is kept for 31 days & that someone is able to download footage.

██████████ was also reminded that he must stick to his licensable hours as it was reported a few months ago after his licensable hours that approx 10 people were seen playing poker in the pub when the pub should be shut. Drinks were also seen by Police Officers. ██████████ was informed that further checks would be conducted.

I would like to confirm in writing that you as the Premises Licence Holder (PLH) and Designated Premises Supervisor (DPS) of LA Study Pub, 312 High Street, Slough, Berkshire, SL1 1NB, have been informed that in relation to the breach of your Premises Licence which was found by Debie Pearmain, Police Licensing Officer on Friday 16<sup>th</sup> May 2025 namely:

**Condition 11** – Incident Register to be in place and kept up to date and made available upon the request of the Thames Valley Police and authorised Licensing Officers and be kept for a minimum of one year.

No Incident Register could be shown to the Police Licensing Officer.

**Condition 16** - DPS or nominated person is an active member of the Local Pub Watch scheme when in existence.

DPS or nominated person does not attend the local Pub Watch meetings.

**Condition 22** – A Refusal book shall be kept at the premises and updated as and when required and made available for inspection on request to an Licensing Officers, Police or other responsible authority.

No Refusal book could be shown to the Police Licensing Officer.

**Condition 25** – Personal Licence Holder to be on site from 5pm until close every day.

Minimum of 2 x SIA door staff to be on duty on a Friday and Saturday evening from 8pm until close and at any other time as advised by Thames Valley Police or the Local Authority. Door staff to be wearing high visibility jackets.



No Personal Licence Holders were on site at the time of our attendance.

No SIA door staff were on site or working at the premises.

**Condition 29 – Any garden furniture to be removed at 10pm each day of the week.**

Garden furniture was still in place at the 2225 hours at the front of the premises.

The above are breaches of your Premise Licence. Therefore, this warning letter has been issued to you as the Premises Licence Holder and Designated Premises Supervisor.

This letter will be classed as a Police Warning and a copy of this letter will now be placed on the Premises Licensing file for LA Study Pub, 312 High Street, Slough, Berkshire, SL1 1NB and will be used in evidence at a licensing panel hearing if any of the Licensing Objectives are undermined or any further breaches found.

During this visit we have established that the person that holds the license to sell alcohol was not there and apparently had to leave the premises for a short amount of time, the whole time POLICE were there, he did not come back. No-one at the premises had a Personal licence to sell alcohol.

No-one in the premises at the time knew or had access to CCTV.

They do not employ door staff at the premises as they say they do not need it unless it's for special events is what they claim.

CCTV and Tills show correct time, no issues with that.

The bathroom is not acceptable. The initial door to get in is not properly secure with a cheap lock, then once you walk in there is another door to go through and lock to go to the toilet, that door does NOT lock properly and the door is not a full door and there is a big gap at the top which is easy to look over if someone was in the toilet and was not aware that there is a lock on the initial door to get into the bathroom area

Gents and Ladies toilets are mixed

No disabled toilet.

Fire exit is clear, no issues.

LA Study Pub has the below conditions:

"Personal Licence Holder to be on site from 5pm till close every day.  
Minimum of 2 x SIA door staff to be on duty on a Friday and Saturday evening from 8pm until close and at any other time as advised by Thames Valley Police or the Local Authority.

Door Staff to be wearing high visibility jackets.

Whilst SIA Security Personnel are employed at the premises all will be deployed with digitally recording Body Worn Video (BWV).

Any garden furniture at the front of the pub to be removed at 10pm each day of the week."

I visited Sat 11th Oct at 22:30 and the furniture out the front was still out and there were no security staff present, and no one in high vis or with BWV.

I spoke with [REDACTED] 2006 who said he is the personal license holder. I initially asked him what his conditions were and he said he needed to bring the tables in and make sure there was no shouting. He did not remember needing to have security. I reminded him of his meeting on 15th October.

This was the 3rd arranged meeting as the PLH/DPS had failed to attend 2 of the meetings. Debie read out the breaches that have occurred since the Licensing meeting █████ attended on the 03/06/2025 where he was given a Police Warning for breaches found during a Licensing visit on the 16/05/2025.

Debie also requested the landlord's details which █████ was not able to give at the time of the request. █████ was asked to email Debie the details today.

Debie explained that due to the continual breaches of this Premises Licence she had no other option but to now apply to review the Premises Licence. █████ has been advised on several occasions to adhere to the conditions on the Licence. The PLH/DPS has complete disregard for Licensing laws.

Debie asked █████ if he had anything to say, to which he replied, "No".

Debie explained that once the review paperwork had been submitted he will be sent a copy and that in the meantime he must adhere to all of the conditions.

When questioned, was advised that they were closed, however, several people still inside the premises drinking alcohol, and the front door was open to the public.

All persons denied being employees, except 1 male, who stated he had the keys to lock up after he had cleaned. Several males found in a room to the rear of the building, gambling. Full size poker table in situ. Alcohol being consumed and cigarettes being smoked inside the premises
