### Nature of Incident – what happened?

During regular HIGH VIS patrols of SLOUGH HIGH STREET, throughout the evening of 25/10/2025, No SIA door staff were seen to be on duty at LA STUDY PUB during the evening from 8pm until close.

No High Vis jackets or BWV video on site. Garden furniture remained outside the front of the pub post 10pm, but had been unused all evening.

Licensing check completed by police at 22:20, members of public still onsite drinking, still no door staff. Licence holder was onsite. When asked about the door staff, LICENSEE stated that they had gone home 2 or 3 minutes earlier, despite police advising that they had been passed the premises several times that evening and noted that there were NO door staff in situ.

LICENSEE was asked what time the door staff had started and he stated 22:00hrs, but they had left just before police had attended to do the check, as they were planning on closing early. When asked by officers why MOP had been found onsite in a back room smoking inside the premises and gambling illegally, he denied this had happened. Licensee, also denied not being onsite during the previous licence check, stating that he had just popped out to get food, despite police being onsite for around 30 minutes.

Licensee, blatantly lied to police about door staff having been onsite when they hadn't been. Denied any knowledge of the previous licence check visit, stating he had been on site, and no-one had been smoking or gambling inside the premises, despite this being captured on BWV.

Licensee was not bothered about the breaches.
