Summary

- 1. The issues at the May 2024 General Election were widely reported at the time, relating to the dispatch of Postal Votes to voters in the Chelmsford wards of the North West Essex Constituency.
- 2. Shortly following the General Election, the Leader, Cllr Petrina Lees, commissioned Peter Stanyon, Chief Executive of the Association of Electoral Administrators, to carry out an independent expert review of what happened, and to make recommendations for the future.
- 3. Simultaneously, the Electoral Commission considered all such issues that arose around the country against performance standards issues in respect of the UK Parliamentary General Election. The Commission sets performance standards for Returning Officers which are designed to support the delivery of a consistent, high-quality service for voters and those standing for election, and monitors and reports on performance against these. Following the moderation process (including review of the error by the Electoral Coordination Advisory Board and a final assessment by the Director of Electoral Administration & Guidance) the Electoral Commission has now determined the error does not require formal assessment, and this brings their formal moderation process to a close.
- 4. Mr Stanyon's review report has now been received, with recommendations, and is presented in full to Members.
