The Council has a duty to maintain an effective Internal Audit service that is compliant with the UK Public Sector Internal Audit Standards (PSIAS) so that the Audit Manager can provide an annual report and opinion on the adequacy and effectiveness of the organisation's corporate governance, risk management and internal control. This can be used by the organisation to inform its annual governance statement.
- 7. The Internal Audit Plan is designed to provide the body of evidence the Audit Manager needs in order to support the annual report and opinion. This report summarises the progress made against the plan in the first third of the 2024/25 financial year and is attached as Appendix 1. The reports for audits with a "Limited" opinion can be found in Appendix 2.
- 8. One of the requirements of Public Sector Internal Audit Standards are that the service undergoes a periodic external quality assessment. Arrangements were made for Havering Council to perform this work (through the London Audit Group). This work has been concluded and their report is shown in Appendix 3.
