Council Tax Resolution 2025/26

Summary

1. The purpose of this report is to enable the Council to calculate and set the council tax for 2025/26.

Precepts and Council Tax Requirement

- 2. The Council has received the following precepts in respect of 2025/26:
 - Essex County Council met on 13 February 2025 and set their precept at £64,055,786. This results in a band D council tax charge of £1,579.59, an increase of £57.06 (3.75%) on the previous year. This comprises a 2.0% increase for the adult social care precept, and a 1.75% increase for general council tax.
 - The Essex Police, Fire and Crime Panel met on 4 February 2025 and endorsed a precept for Essex County Fire and Rescue Service of £3,551,153. This results in a Band D council tax charge of £87.57, an increase of £4.95 (5.99%) on the previous year.
 - The Essex Police, Fire and Crime Panel met on 4 February 2025 and endorsed a precept for Essex Police of £10,558,566. This results in a band D council tax charge of £260.37, an increase of £13.95 (5.66%) on the previous year.
 - The precepts raised by town and parish councils are detailed at Annex B2 and total £5,186,478. This results in an average band D council tax charge of £127.90, an average increase of £7.25 (6.01%) on the previous year.
- The Cabinet of Uttlesford District Council met on 13 February 2025 and decided to recommend a Council Tax Requirement for the District Council of £7,381,304 (subject to approval by Full Council). This results in a band D council tax charge of £182.02, an increase of £5.28 (2.99%) on the previous year.
- 4. The total council tax to be raised, including on behalf of preceptors, is therefore £90,733,287. This results in an average total band D council tax charge of £2,237.45, an increase of £88.49 (4.12%) on the previous year.
- 5. All proposed council tax increases are within the relevant referendum principle limits for 2025/26 as set by the government, therefore no referendum is required in respect of the Council's area.

Average Council Tax Charges

6. Subject to approval of the Council Tax Resolution at Annex B1, the following table sets out the breakdown of the average band D council tax bill for 2025/26:

Council Tax Resolution 2025/26

The Council is recommended to resolve as follows:

- 1. To note that on 4 December 2024 the Strategic Director of Finance, Commercialisation and Corporate Services (Section 151 Officer), acting under delegated authority, calculated the following council tax base for 2025/26:
 - (a) Taxbase for the whole council area is 42,505.96 band D equivalent properties, before adjusting for Local Council Tax Support discounts
 - (b) For the whole council area, the estimated value of Local Council Tax Support discounts is a taxbase reduction of 1953.80 band D equivalent properties.
 - (c) Taxbase for the whole council area, after adjusting for Local Council Tax Support discounts is 40,552.16 band D equivalent properties, this being the figure to be used for council tax calculation purposes.
 - (d) Taxbase for those parts of the council area to which a town or parish council precept relates are as shown in Annex B2.
- 2. To determine that the Council Tax requirement for the Council's own purposes for 2025/26 (excluding town and parish council precepts) is £7,381,304.
- 3. That the following amounts be calculated for the year 2025/26 in accordance with Sections 31 to 36 of the Local Government Finance Act 1992, as amended (the Act):-

(a) £109,359,073	Being the aggregate of the amounts which the Council estimates for the items set out in Section 31A (2) of the Act taking into account all precepts issued to it by town and parish councils.
(b) £96,791,291	Being the aggregate of the amounts which the Council estimates for the items set out in Section 31A (3) of the Act.
(c) £12,567,782	Being the amount by which the aggregate of 3(a) above exceeds the aggregate at 3(b) above, calculated by the Council in accordance with Section 31A(4) of the Act as its Council Tax Requirement for the year (including town/parish precepts).
(d) £309.92	Being the amount at 3(c) above, divided by the Council Tax Base shown at 1(c) above, as the basic amount of its Council Tax for the year (including town and parish precepts).
(e) £5,186,478	Being the aggregate amount of all special items (town and parish precepts) referred to in Section 34(1) of the Act (as per the attached Annex J2).
(f) £182.02	Being the amount at 3(d) above less the result given by dividing the amount at 3(e) above by the council taxbase shown at 1(c) above, calculated by the Council, in accordance with Section 34(2) of the Act, as the basic amount of its council tax for the year for dwellings in those parts of its area to which no town or parish precept relates.

- 4. To note that Essex County Council and the Police, Fire and Crime Commissioner ('PFCC') for Essex have issued precepts to the Council in accordance with Section 40 of the Act for each category of dwellings in the Council's area and these are shown in the table at point 5 below.
- 5. That the Council, in accordance with Sections 30 and 36 of the Act, hereby sets the aggregate amounts shown in the table below as the amounts of council tax for 2025/26 (excluding town and parish council precepts) for each part of its area and for each of the categories of dwellings:

- 6. To determine that the Council's basic amount of council tax for 2025/26 is not excessive in accordance with the principles approved under Section 52ZD(1) of the Act, therefore no referendum is required, as shown in the calculation below:
 - a. Amount defined by the Secretary of State as constituting an excessive basic amount for 2025/26: an increase of 3% (or more than 3%), or more than £5.00, whichever is greater.
 - b. Change in the Council's basic amount of Council Tax: £5.28 or 2.99%
- 7. That the Council, in accordance with sections 30 and 36 of the Act, hereby sets the aggregate amounts shown in the table at Annexe J3 as the amounts of council tax for 2025/26 (including town and parish council precepts) for each of the categories of dwellings in each relevant part of its area.
