		As part of this, the Council agreed to support the Royal British Legion's 'Credit their Service Campaign' and to promote the discretion that can be applied for recipients of the Armed Forces Compensation Scheme.
		This year 33 Engineer Regiment exercised the freedom of the District with a parade through Saffron Walden, with large crowds attending to support the Military.
		It was excellent that the Council agreed to grant the Freedom of the District to 35 Engineer Regiment, and we are looking forward to them finding an opportunity to exercise their freedom within the District at some point soon in the future
		UDC staff used volunteering days to support the Community Tidy-up of the Carver Barracks communal family areas, as part of ongoing efforts to continually strengthen relations between the Council and the local Armed Forces community.
