Summary

1. It is proposed to deliver Round 4 of the Zero Carbon Communities (ZCC) Grant Scheme to support delivering the Council Corporate priority to provide community leadership and enable local action on climate change.

- 2. £80,000 has been allocated from the Climate Budget Reserve to enable delivery of the Fund in 2025/26. Individual grants have a maximum value of £10,000.
- 3. Round 4 of the ZCC Grant Fund will use a similar application and award process that was established in previous rounds. However, as the overall fund and individual grants are smaller, it will not be necessary to seek Cabinet approval of the successful bids. The grant awards will still be managed in a fair and transparent way with evaluation of applications against clear grant criteria, concluding with a moderation panel.

Recommendations

- 4. To approve the plan to launch round 4 of the Zero Carbon Communities Grant Fund in October.
- 5. To note the timeline and milestones outlined for the application and selection of the successful projects.

Financial Implications

6. The total amount of funding awarded through the Zero Carbon Community Grant Fund to date is £476, 188, broken down as follows:

- 7. £80,000 is identified from the Climate Reserve Budget to deliver round 4 of the Zero Carbon Communities Grant Fund in 2025/26
- 8. In round 4 applicants will be able to apply for grants up to a maximum of £10k, with applicants needing to demonstrate a % of match funding available, depending on the value requested.
- 9. Grant payments will only be released to a project when Officers are in receipt of a signed agreement and any other requested information, to confirm that conditions of the funding have been accepted and/or met by the applicant.

Situation

- 11. The Zero Carbon Communities Grant Fund provides an opportunity for the Council to continue to deliver a district programme of community engagement on climate action. The fund will enable the growing network of community Climate Action groups to establish themselves through engaging local communities and residents in delivering 'low carbon' and 'high nature' projects on the ground.
- 12. Engagement through the Zero Carbon Communities Grant Fund enabled the creation of a networking group Sustainable Uttlesford in late last year, and since then the Council have collaborated to formalise Sustainable Uttlesford (SU) as a community organisation, with the intention to build on the legacy of the Zero Carbon Communities Grant Fund.
- 13. Sustainable Uttlesford and the Council will collaborate to deliver the Uttlesford Big Green Festival from 6th to 14th June 2026. A range of community events and activities will take place across the district to celebrate projects and the action being taken in Uttlesford to tackle climate change and protect nature.
- 14. As in previous rounds the fund will be open to community groups and parish/town councils delivering projects that reduce carbon emissions; projects

- that restore or enhance biodiversity, and projects which engage communities in taking climate action.
- 15. To date the grant scheme has funded 41 community projects. These include net zero infrastructure community projects such as installation of solar PV and energy conservation measures on community buildings and facilities; alongside community projects that provide energy surveys, advice and support to residents to install retrofit measures via their own means or via available government grant schemes. Grants have also been used to deliver local biodiversity studies and projects, river restoration and wetland projects and support to a farm cluster.
- 16. The Climate Change team will monitor and engage with all projects and share success stories and case studies via the Zero Carbon Communities Newsletter. Council communications channels and local media.
- 17. All projects will be asked to provide a method for how they will evaluate and measure the impact of their project. For projects delivering interventions to reduce carbon emissions, the impact will need to be quantifiable. It is expected that all projects will engage with others in their community on climate action.
- 18. The below table sets out high level timeline and key milestones for delivering round 4 of the Zero Carbon Communities Grant Fund:
