## 1. Summary

- 1.1. Council is asked to approve a draft programme of Ordinary Meetings of the Council for the year, to be finalised at the next Annual Meeting.
- 2. Recommendation
- 2.1. To approve the draft meetings programme for 2024-25 as set out in Appendix 1; and
- 2.2. To note that the programme will be finalised at the Annual Council Meeting on 23 May 2024.

## 3. Background

- 3.1. The Council Procedure Rules state that a draft meetings programme, be agreed at a Council meeting before it is finalised at the Annual Meeting.
- 3.2. This will give early notification of meeting dates and enable councillors to enter meeting dates in their diaries, recognising that the final decisions on establishment and membership of committees at the Annual Meeting on 23 May 2024 may alter the programme.

## 4. Proposal

4.1. The proposed dates of Council, Cabinet, Committees, and other bodies in 2024/25 are set out in the attached schedule (Appendix 1). The schedule is based on the current frequency of meetings, but accounts for the recommendation to change the scrutiny committee structure that was agreed at the Council meeting held on 14 December 2023. It

- is possible that changes may need to be made to the schedule following approval.
- 4.2. The meetings schedule for 2024/25 will be finalised at the Annual Council meeting on 23 May 2024 as required in the Council's Constitution. It is also proposed, where appropriate, to submit to the first meeting of a committee following the AGM a list of its meeting dates for the following 12 months. Consequently, there will be further opportunities for changes to meeting dates if required.
- 4.3. The number of meetings of each council body scheduled in the 2024/25 Municipal Year (i.e. between June 2024 and May 2025 is as follows:
