## 1. Summary

- 1.1. This report outlines the Scrutiny Annual report for 2024-25, which contains a summary of committee activity for the last municipal year.

## 3. Background

- 3.1. Scrutiny Committees make an annual report to Council, this report is attached as appendix 1 and sets out the work undertaken by the Committees in the year 2024-25.
- 3.2. The report outlines the activity undertaken by each committee and a summary of the recommendations and key impacts made throughout the year. It also includes an overview of the Scrutiny Reviews conducted and summarises the work and impact of the Council's Young Advisors and the Youth Independent Advisory Group on scrutiny committees.

- 3.3. The implementation of the Scrutiny Improvement Review, which took place in 2023 is outlined, updating on the change of remits and the development of the training programme.
- 3.4. At the Council's AGM on 22 May 2025, the membership for scrutiny committees for 2025-26 was agreed. The current list of committees and chairs is as follows:

- 3.5. The Council is a member of 2 Joint Health Overview and Scrutiny Committees (JHOSC), with members electing a Chair at the start of each year.
- 3.6. The committees met in the summer to discuss service priorities and identify items for their forward plans. Cabinet members, senior officers and their teams have been consulted throughout this process. These forward plans are attached as appendix 2.
- 3.7. The Joint Health Overview and Scrutiny Committees (JHOSC) agree their own work programmes.
- 3.8. Committee forward plans may need to change during 2025-26 to accommodate new items, such as where a request for pre-decision scrutiny is made or an urgent report to scrutiny is required. Likewise, deferrals may be requested for some items dependent on circumstances. For expediency, the chair of the relevant committee will be asked to agree its addition to the forward plan.
- 4. Proposal

- 5.1. The committees consulted with officers and Cabinet in order to prepare the forward plans. Committees also engaged with key stakeholders and partners to establish any items which they could contribute throughout the municipal year. Young Independent Advisory Group and Young Advisor members have also had an opportunity to feed into the forward plans.
