The total population of Waltham Forest is **278,400**, of these, approximately **210,200** are adults.







Executive Summary – Consultation

The review of the Section 75 Partnership Agreement took place over April – July 2025 and engaged both internal and external stakeholders.

Insights from the consultation will shape the refreshed Section 75 Agreement, ensuring it reflects the priorities, experiences, and recommendations of staff and stakeholders, strengthening integrated working and improving service delivery.

The internal stakeholder engagement activity was facilitated through the Section 75 Operational Group and the lived experience stakeholder engagement was facilitated through NELFT's Patient Carer Forum.

Executive Summary – Consultation Findings

Across the engagement activity, stakeholders identified the key strengths of the partnership agreement, alongside opportunities for further development, to enhance integrated working and improve resident outcomes.

The consultation discussions were focused on the following areas:

- How to improve the scope and mandate of current arrangements.
- How to improve partnership working.
- What's working well and what needs improvement across delegated functions.

Insights from our Internal Stakeholders:

Areas of Strength Include:

- Effective integrated teams enabling coordinated care, shared accountability, and improved resident experiences.
- ❖ The AMHP service provides timely, multi-agency interventions that reduce hospital admissions through early engagement.
- The partnership supports the Community Mental Health Transformation programme and Mission Waltham Forest.

Areas for Improvement Include:

- Collaborative review of early intervention and prevention to inform future commissioning and improve outcomes.
- ❖ New service priority for carers with mental health needs
- Strengthened governance, accountability, and visibility across NELFT and LBWF.
- Improved IT interoperability to reduce duplication and streamline processes.













Executive Summary – Consultation Findings

Insights from our Lived Experience Stakeholders:

Areas of Strength Include:

- Strong support for continuing the integrated social care model in mental health services.
- Positive feedback on accessing a broader range of services via a single team.
- Commitment to closer collaboration with service users and carers in delivering and overseeing Section 75 arrangements.

Areas for Improvement Include:

- Concerns around the quality and safety of accommodation for individuals with mental health needs in the borough.
- Need for better coordination between care agencies, particularly regarding accommodation standards and clarity on escalation routes.

Moving Forward

- Planned meeting between involvement reps, NELFT Integrated Care Director, and LBWF Director of Transformation to agree on regular engagement mechanisms.
- Strengthen future engagement approaches to ensure continuous improvement and co-production.
- Ongoing monitoring and feedback through compliments and complaints.
- Continued strong engagement via the Patient Carer Forum.
- Ongoing embedding of coproduction and engagement in the Supported Living offer review.
